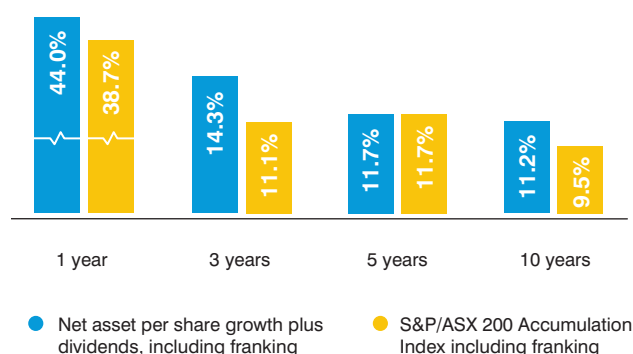

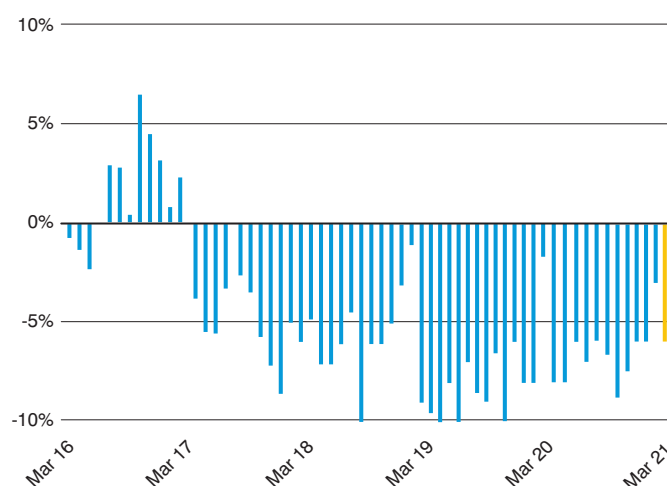
Portfolio performance percentage per annum-periods ending 31 March 2021*

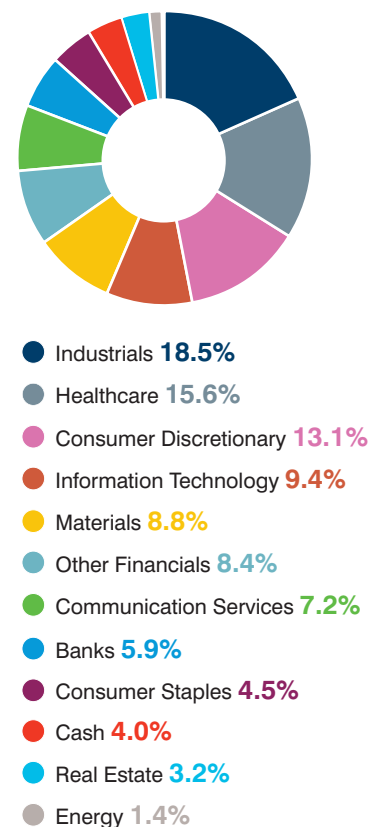
