4Q26 Activity Report – Improved Operating Performance

Anagenics Limited (ASX: AN1, “Anagenics” or the “Company”) today provides an update on activities during the quarter ended 30 June 2026 (“4Q26”).

The Company's operational performance has continued to improve and expects to announce its maiden full year profit for FY26 subject to final audit..

During the fourth quarter of FY2026 (4Q26), the Company had Operating Cash Outflows of \$0.08 million, and trading performance was positive for the period.

The negative cash flow in 4Q26 was primarily driven by the resolution of outstanding creditor payments following the restructure. For the year ending on 30 June 2026 the Company experienced Operating Cash Outflows of \$1.08 million, compared to the cash outflows of \$1.6 million for the year ending on 30 June 2025.

The creditor payments catch-up is now complete, having reduced payables and borrowings from \$2 million at 30 June 2025 to \$0.2 million at 30 June 2026.

The Company paid \$40k in directors' fees in the quarter ending 30 June 2026.

BLC Cosmetics has successfully restructured and is also exploring additional products to expand its portfolio.

During 4Q26, royalty revenue from the YSB product line amounted to \$446k, which is received in July 2026 (1Q27). The Company has invoiced for YSB Royalty revenue of \$1.3 million for the year ending on 30 June 2026.
