## **CAPITAL RAISING BY PRIVATE PLACEMENT AND SHARE PURCHASE PLAN**

Ausmon Resources Limited ("Company") announces a capital raising of up to a total of \$501,710 by way of a private placement of 36,672,972 fully paid ordinary shares ("Share") at \$0.007 per Share to raise \$256,710 ("Placement") and a Share Purchase Plan ("SPP") offering up to 35,000,000 to eligible shareholders at the same price per Share to raise up to \$245,000.

The issue price of the Shares represents an 18.5% discount to the volume weighted average price of Company Shares for the last five days on which they were traded on the Australian Securities Exchange immediately prior to this announcement.

After costs, proceeds from the Placement and SPP will be used for drilling within the Group's exploration licences in NSW and general working capital.

### **Placement**

Patersons Securities Limited will act as Lead Manager to the Placement and the Shares will be offered to sophisticated and professional investors using the capacity available under ASX Listing Rule 7.1. It is anticipated that settlement will occur on or about 12 October 2016 with the new Shares to be issued shortly afterwards. The new Shares will be issued on the same terms as, and will rank equally in all respects with, the existing fully paid ordinary shares of the Company.

### **Share Purchase Plan**

The SPP will provide eligible shareholders registered on the Record Date of 6 October 2016 with the opportunity to apply for up to \$15,000 worth of Shares (subject to any scale back) without incurring brokerage or other transaction costs.

The SPP is to be fully underwritten by Patersons Securities Limited, subject to available placement capacity, or failing adequate capacity, shareholder approval.

The offer document setting out more details of the SPP and the application form will be mailed to shareholders shortly.
