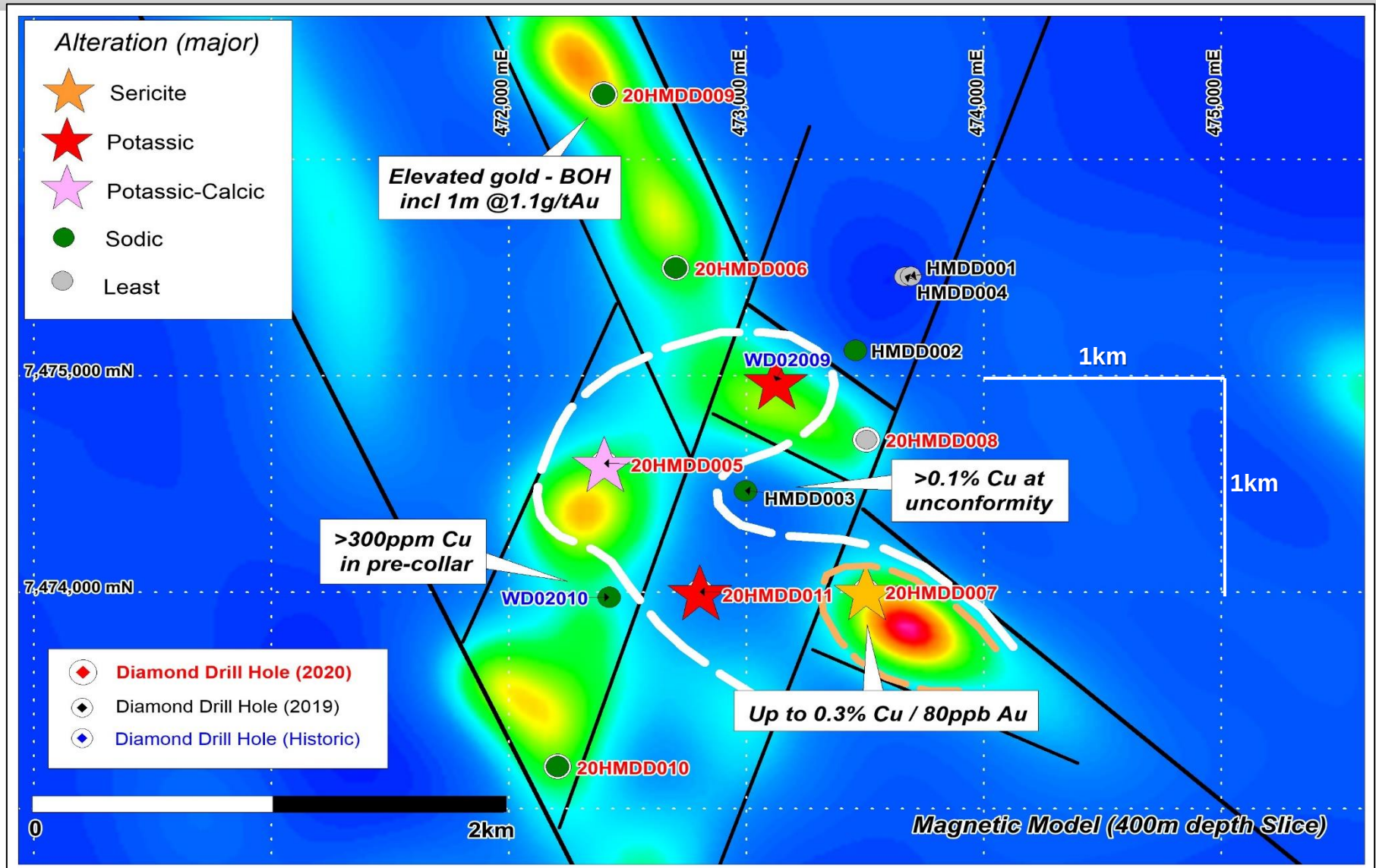


HAMILTON – Copper Gold Project (SAA)



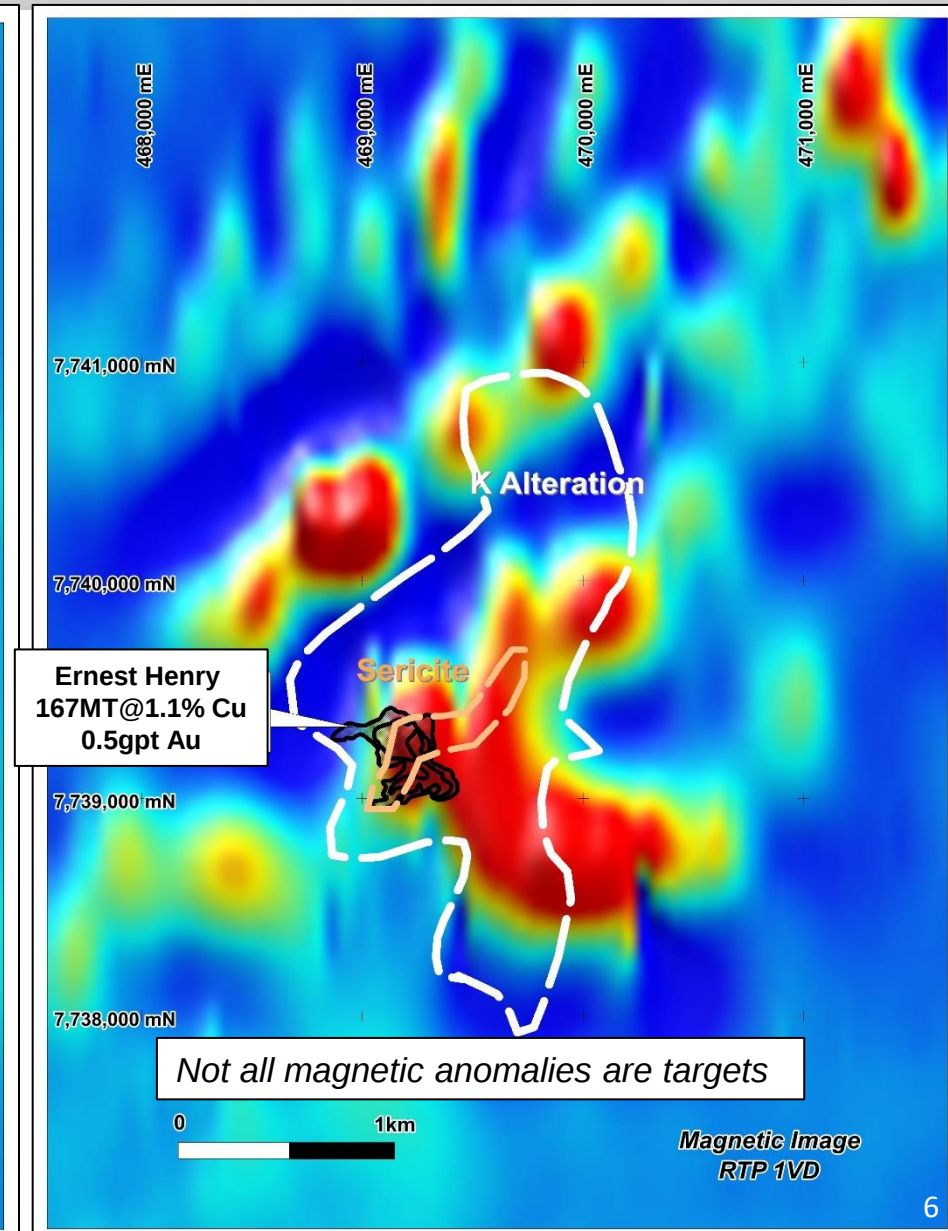
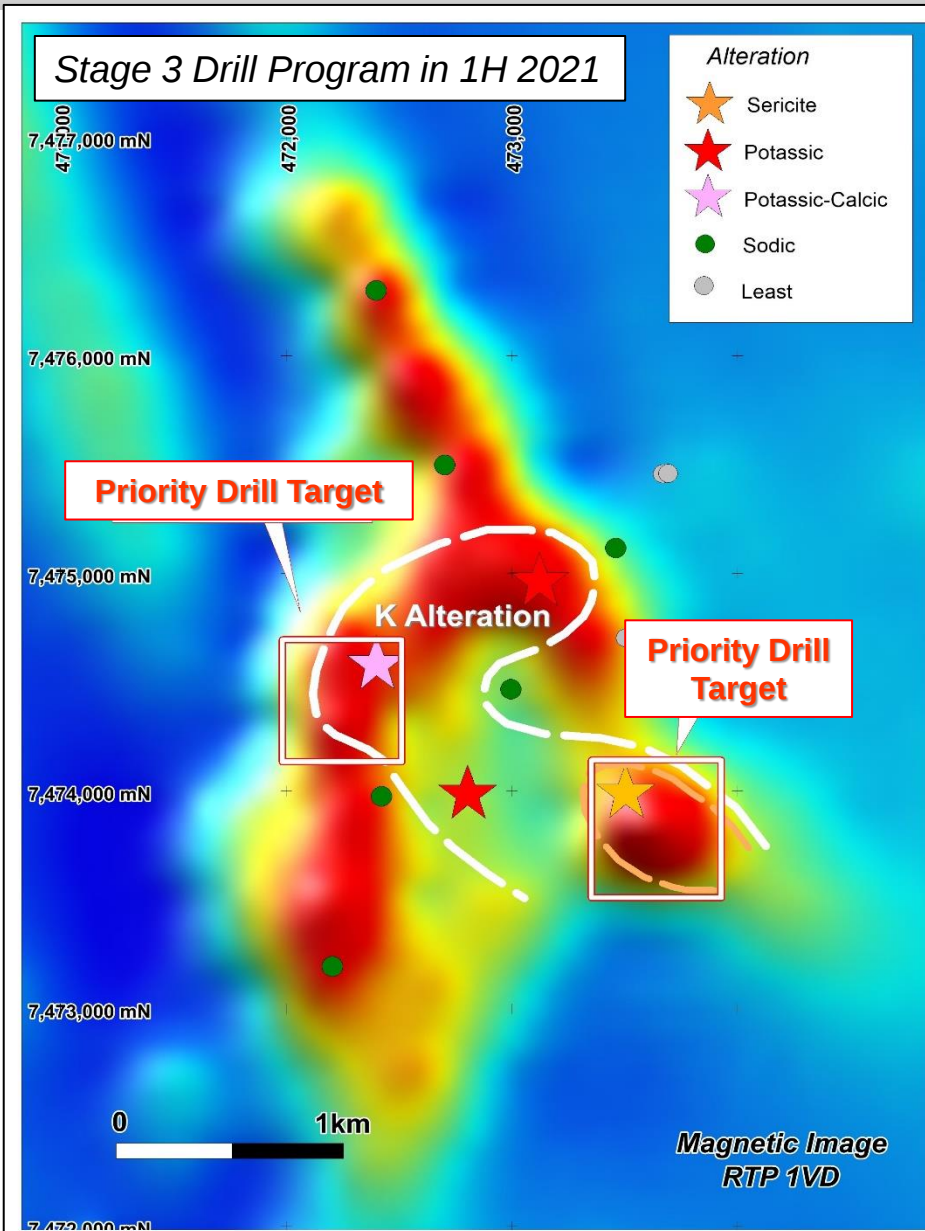
- Under cover but close to Cannington – strong incentive for discovery under SAA

HAMILTON – Drill Alteration Footprint

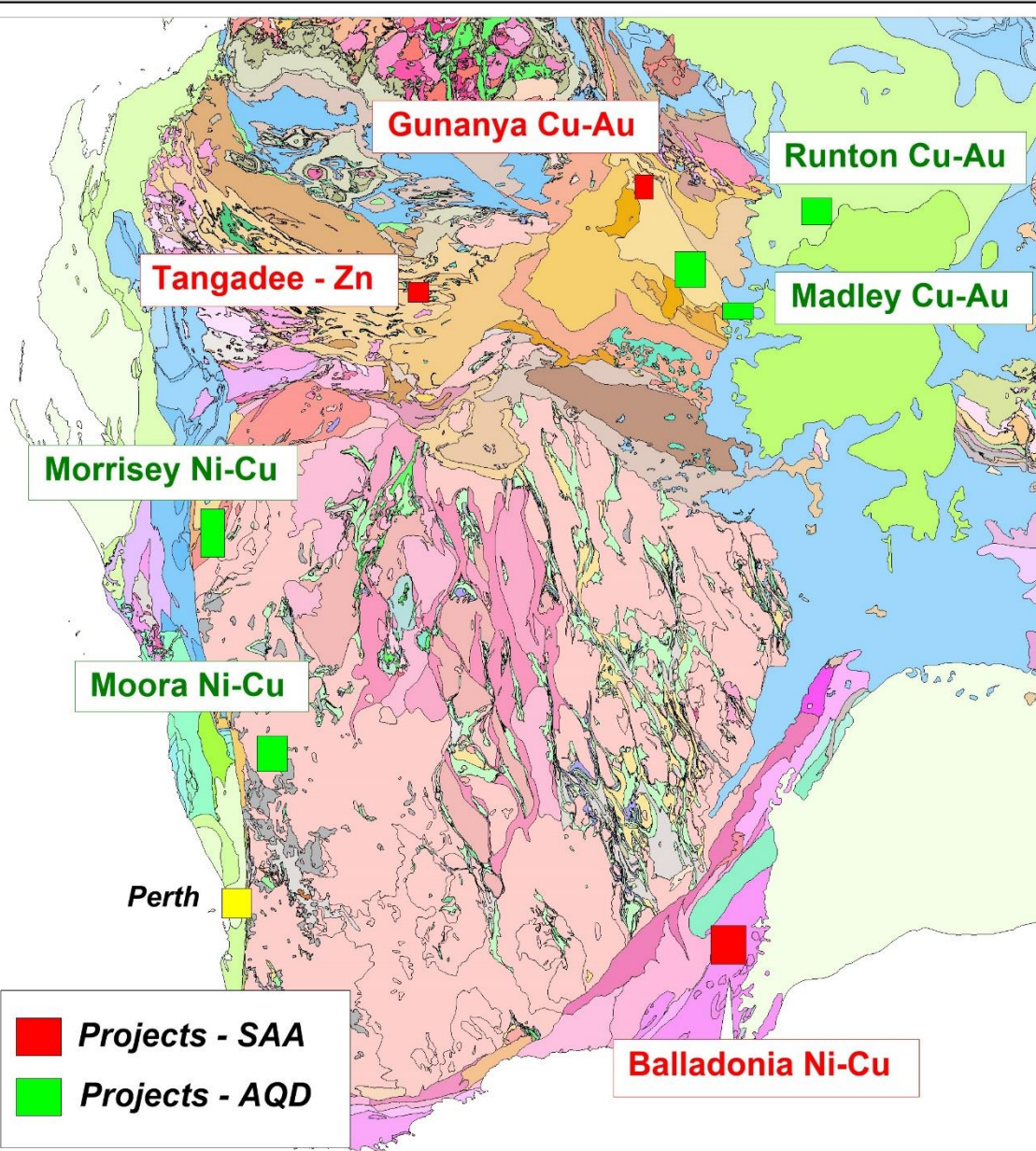


- Large scale alteration footprint + anomalous Cu/Au highlight magnetic targets for drilling

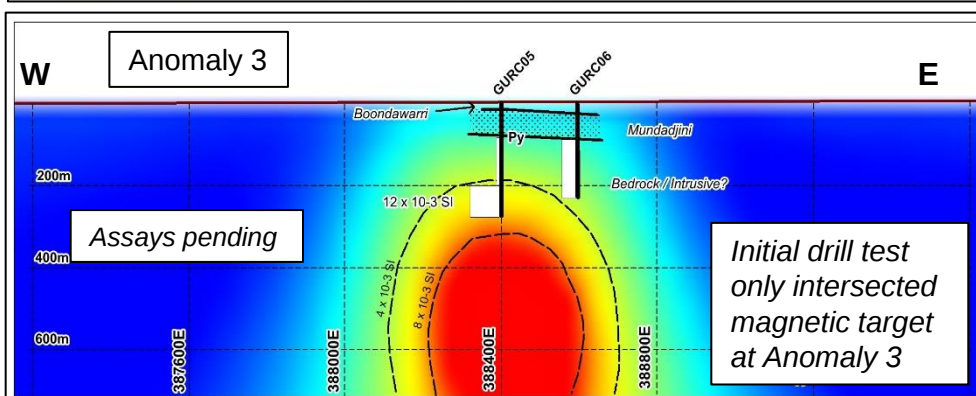
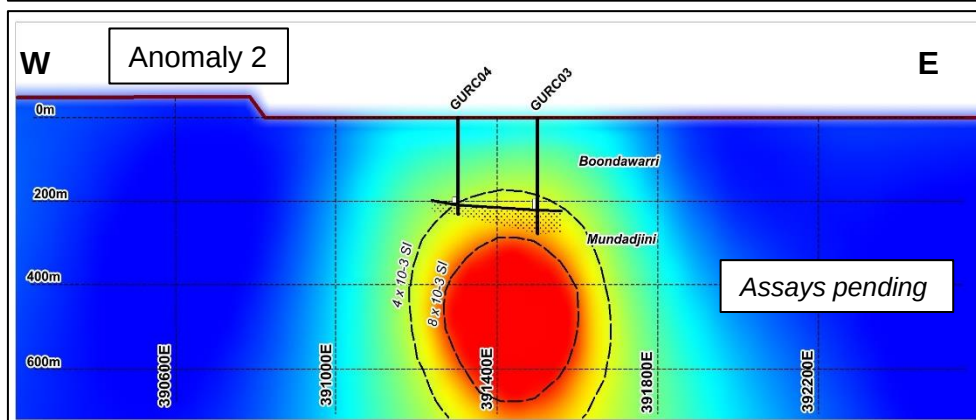
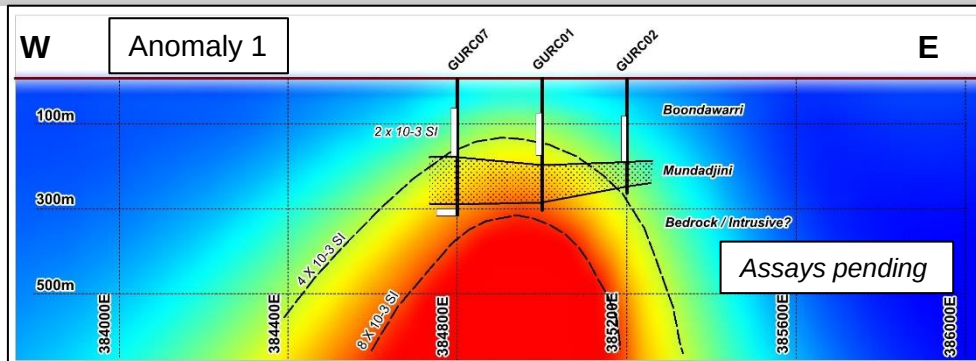
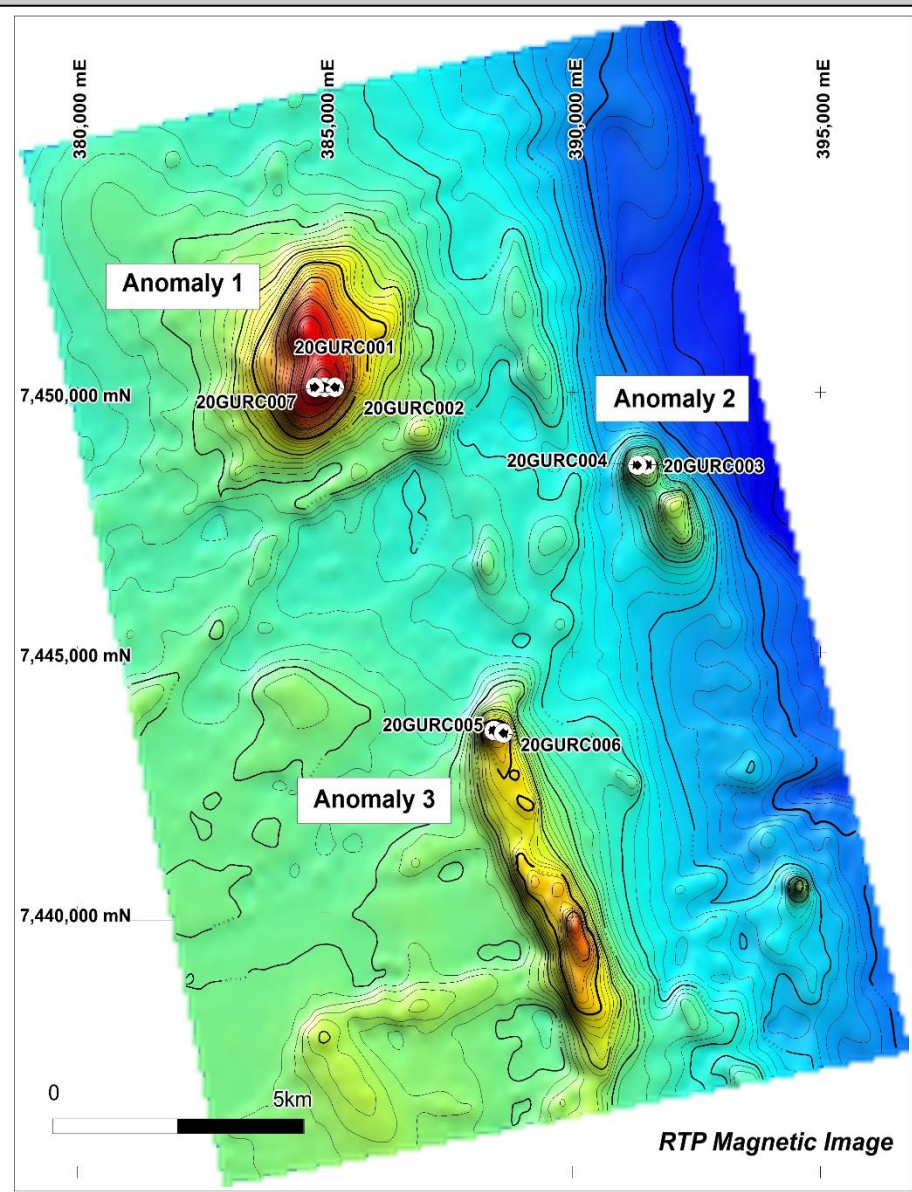
- RC drilling at Gunanya tests magnetic targets for Cu-Au similar to Winu and Havieron - Assays pending

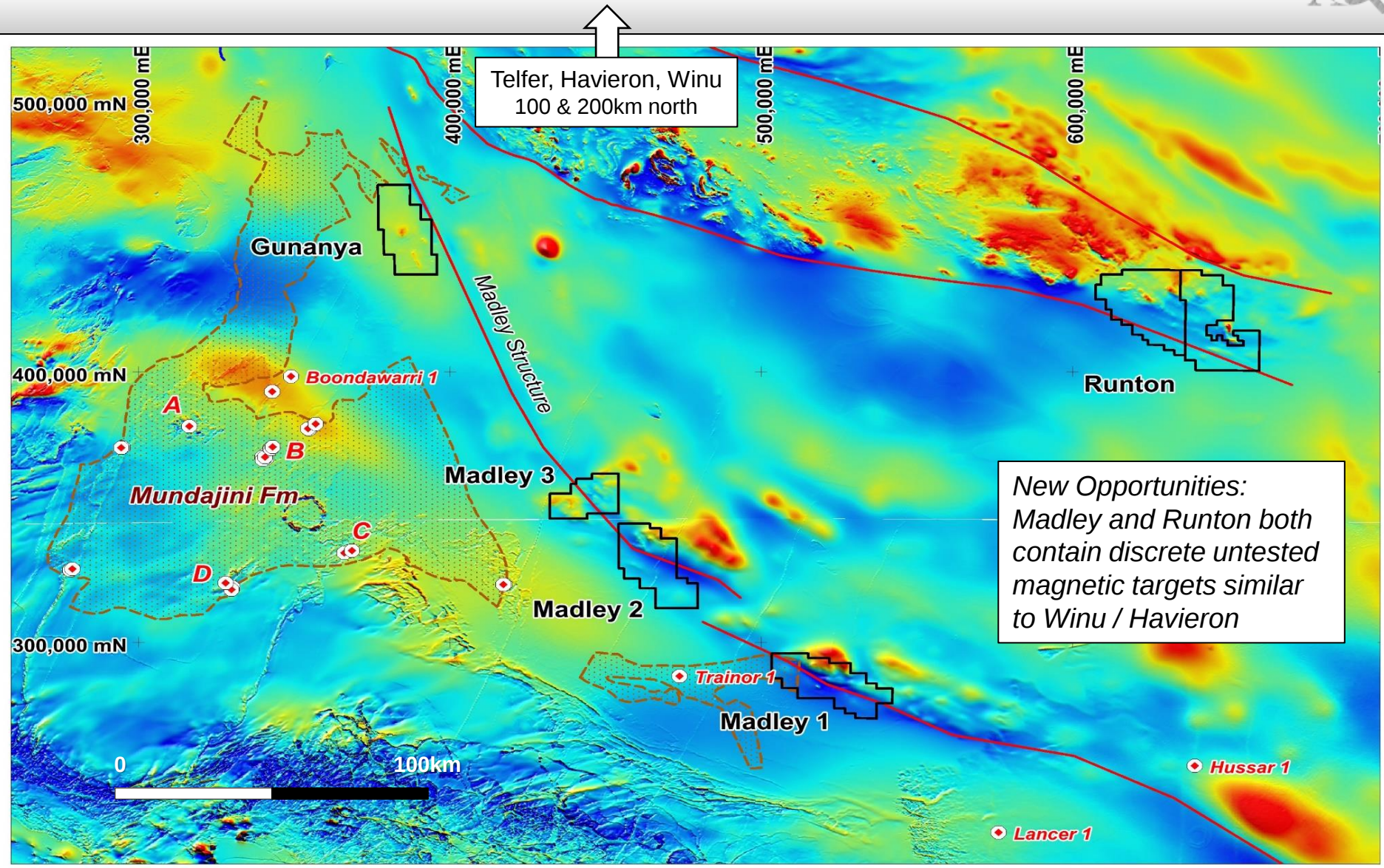

PATERSON – Madley Copper-Gold Targets

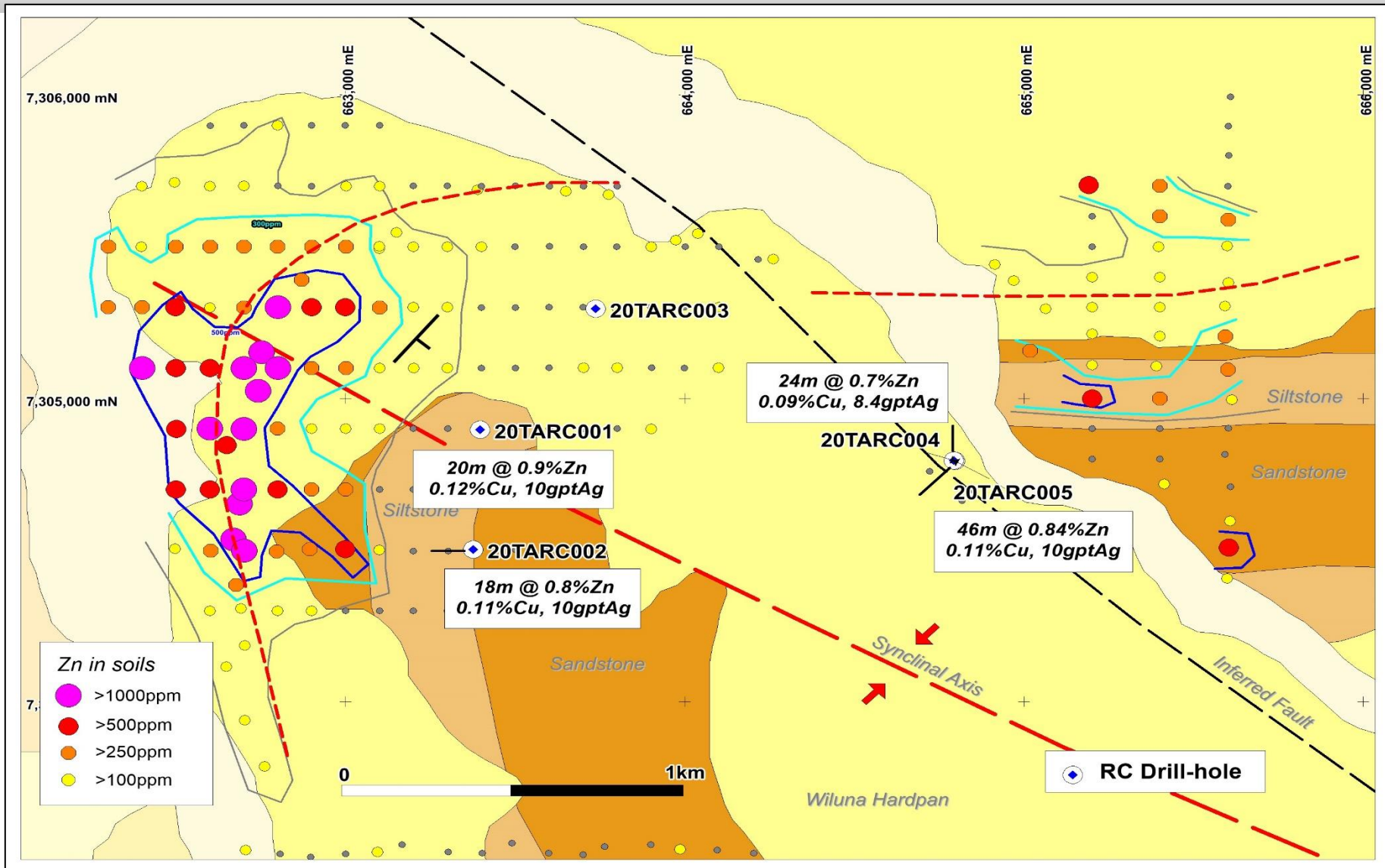


- Detailed magnetics confirms targets close to inferred Madley Fault at depths of ~150m to 300m

BALLADONIA – Copper-Gold Drill Targets

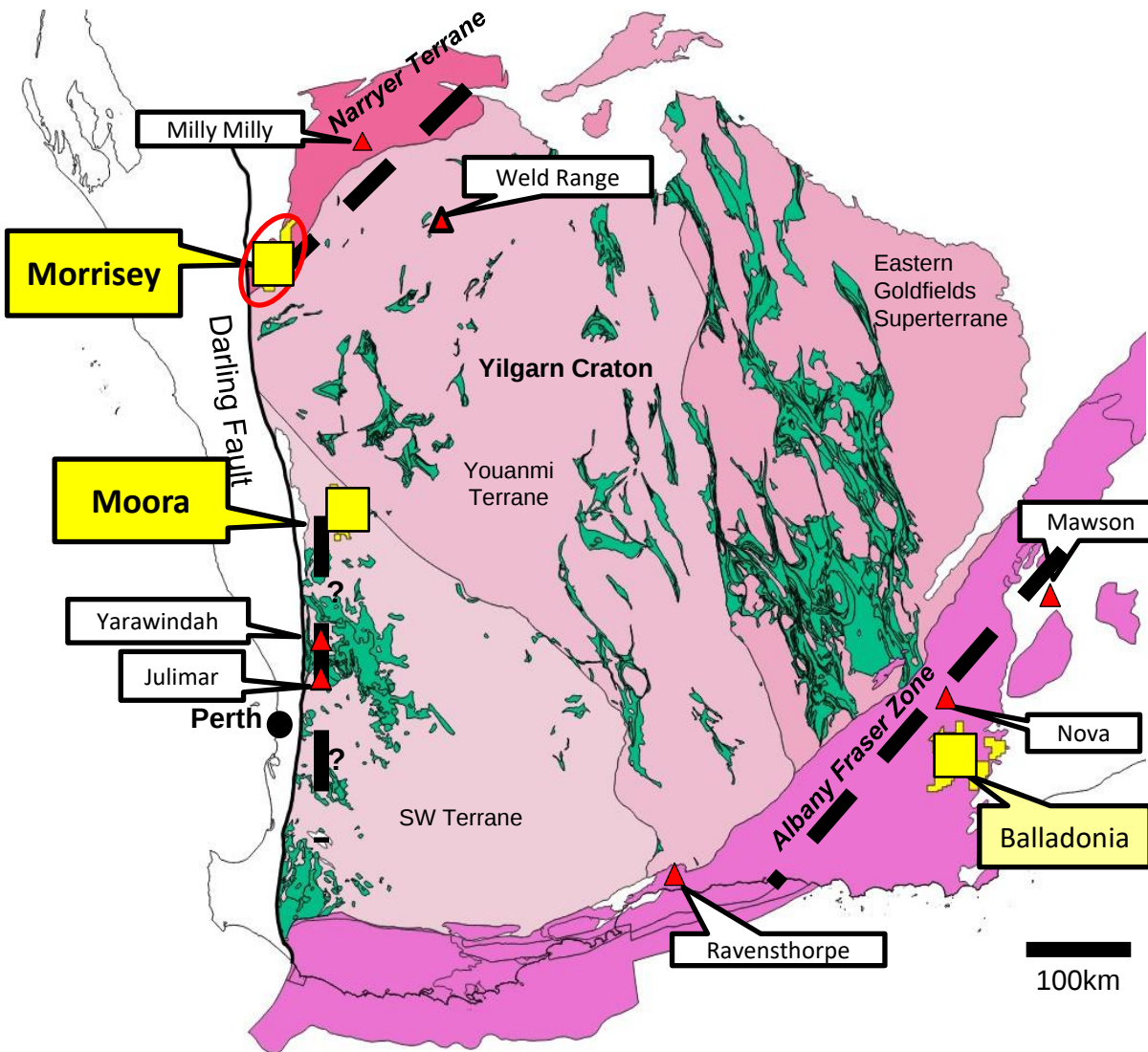


TANGADEE ZINC - RC Drilling Results

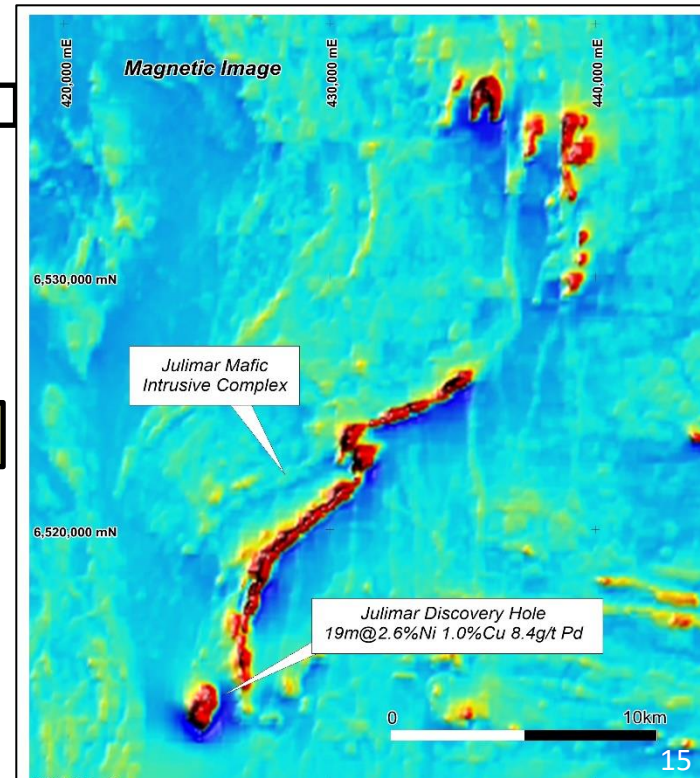


- RC drilling confirms extensive metals but low grades – Regional implications still in play

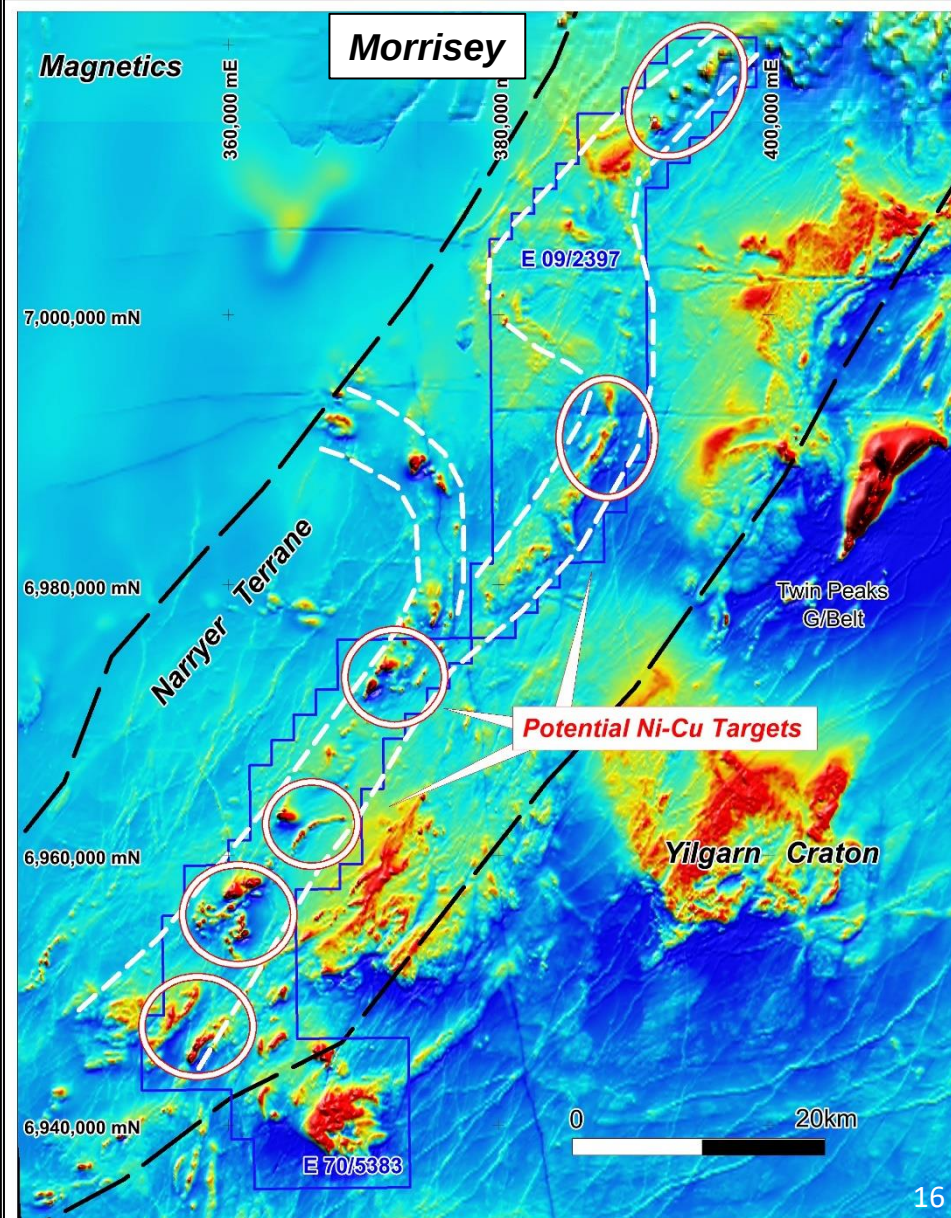
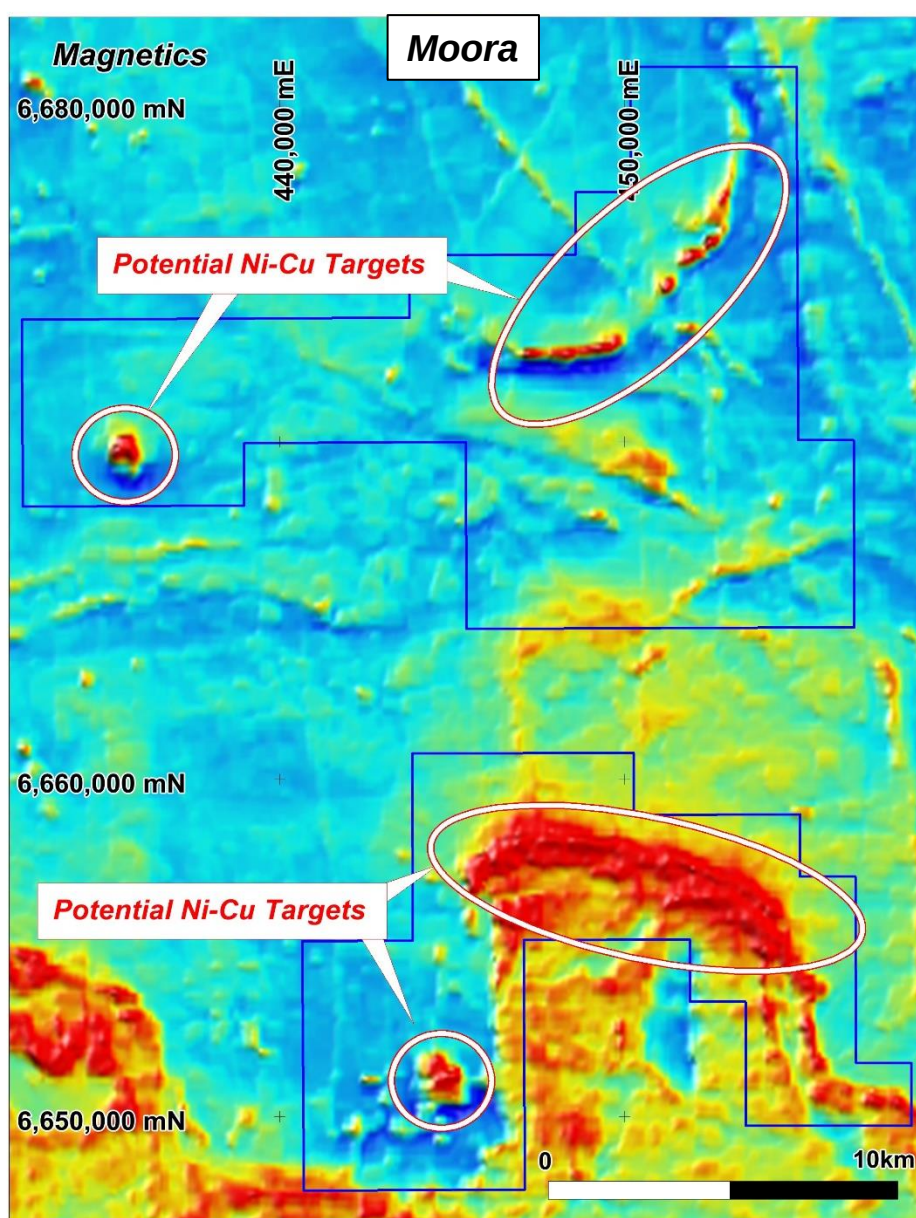
NEW Ni-Cu Opportunities – Western Yilgarn



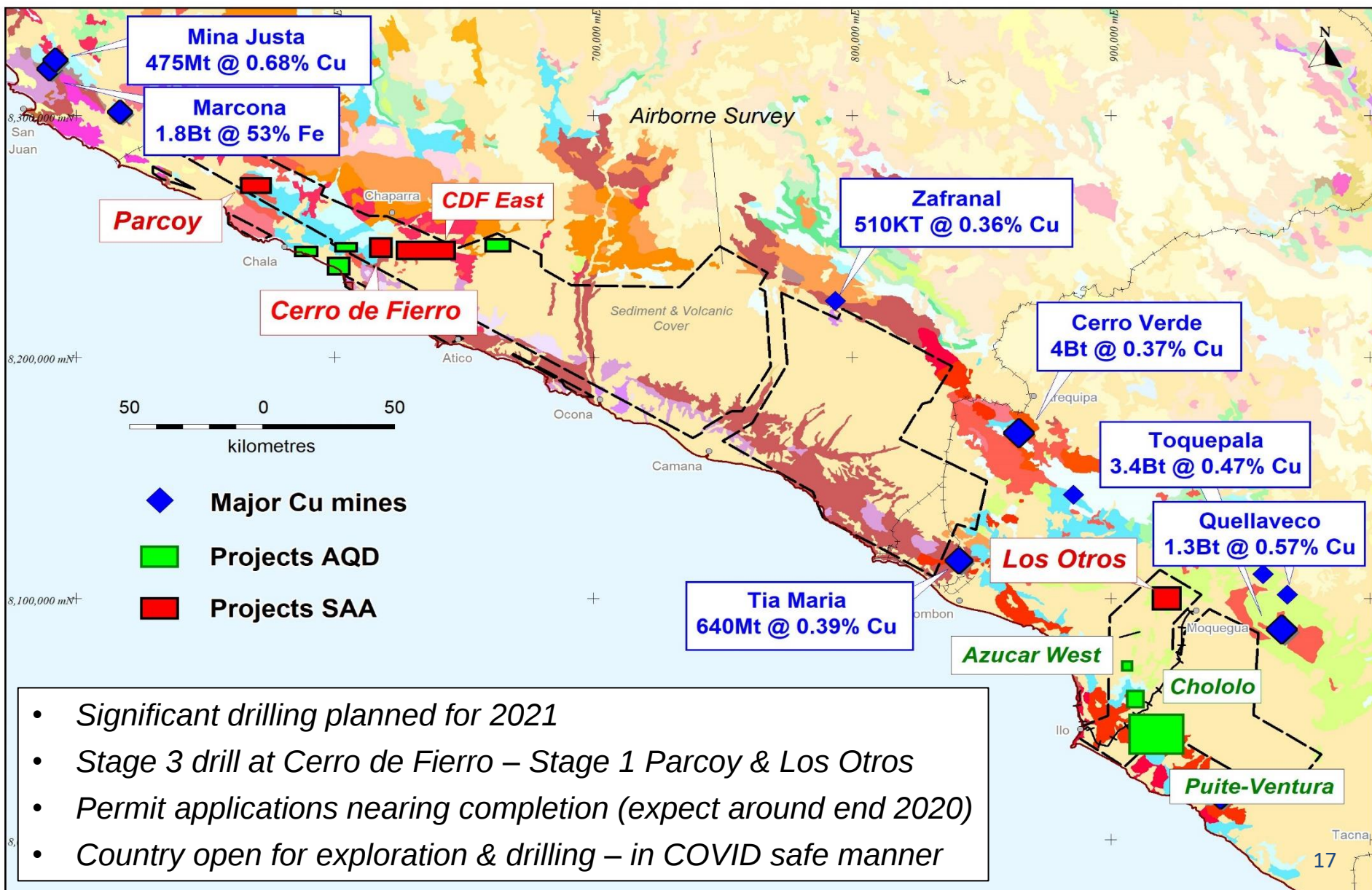
- *Julimar Ni-Cu-PGE discovery focuses attention on western margin of Yilgarn*

MOORA & MORRISEY – New Ni-Cu Targets

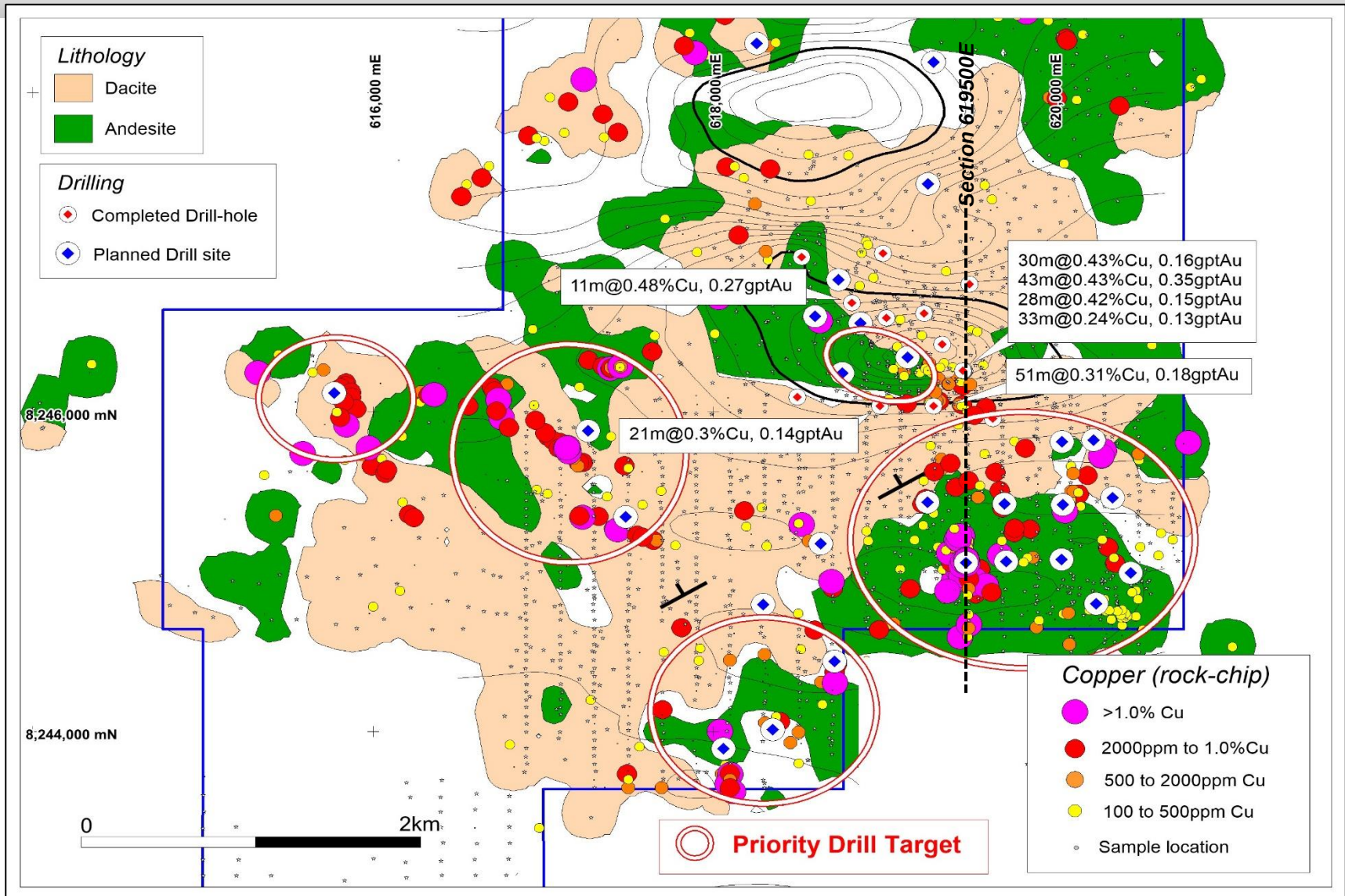


PERU PROJECTS – Copper Country



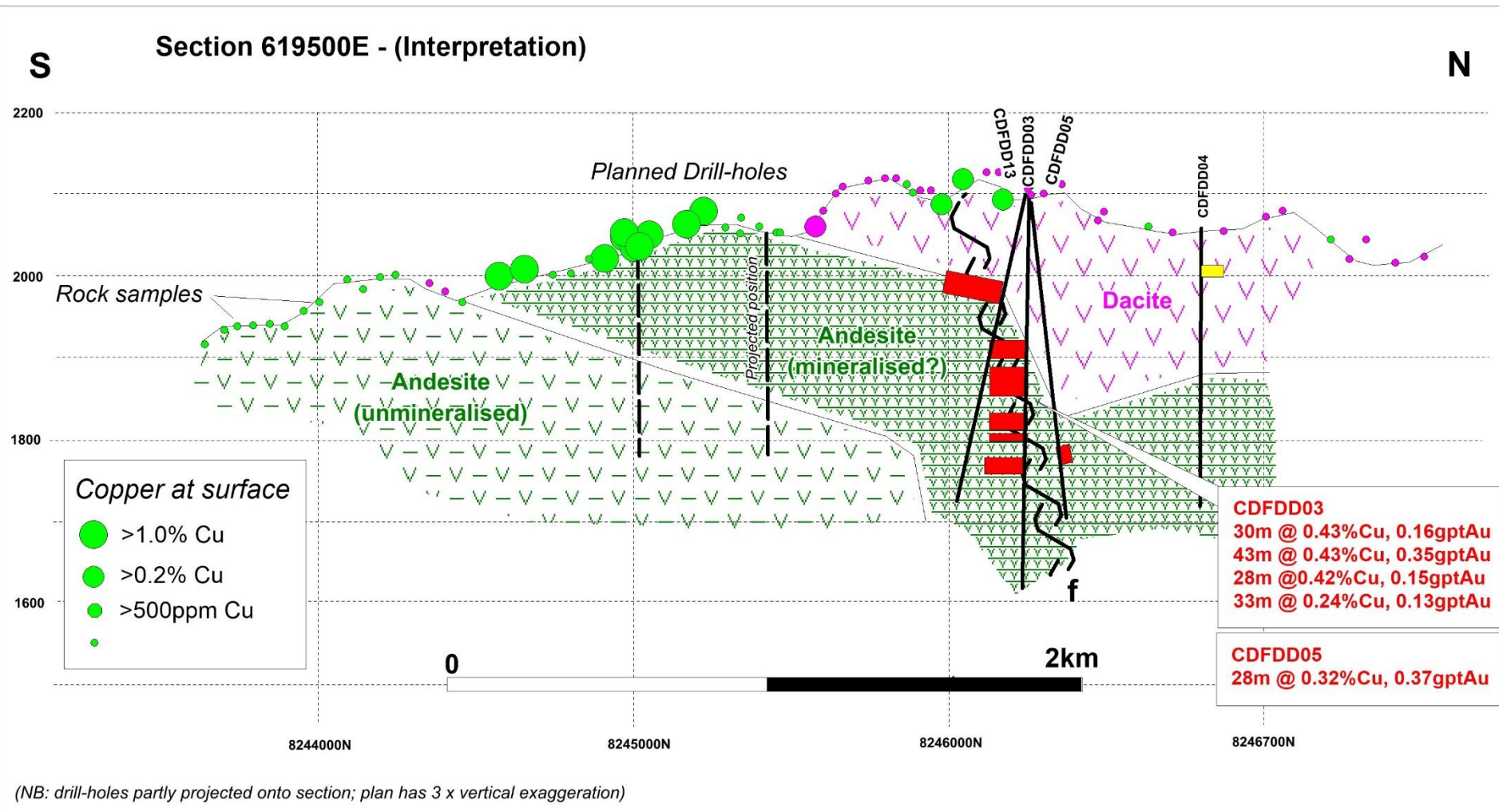
- Significant drilling planned for 2021

CERRO DE FIERRO – Drilling 2020-2021



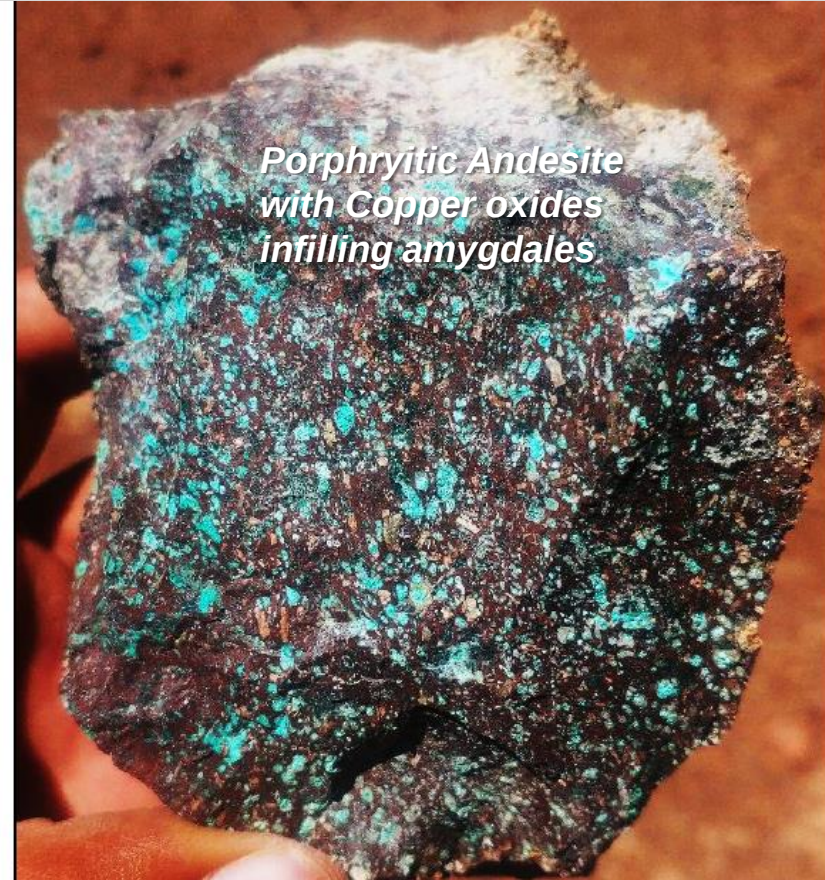
- Significant Cu found at surface - 3rd Stage drilling to test shallow Cu targets in 2021

CERRO DE FIERRO – Section 619500E



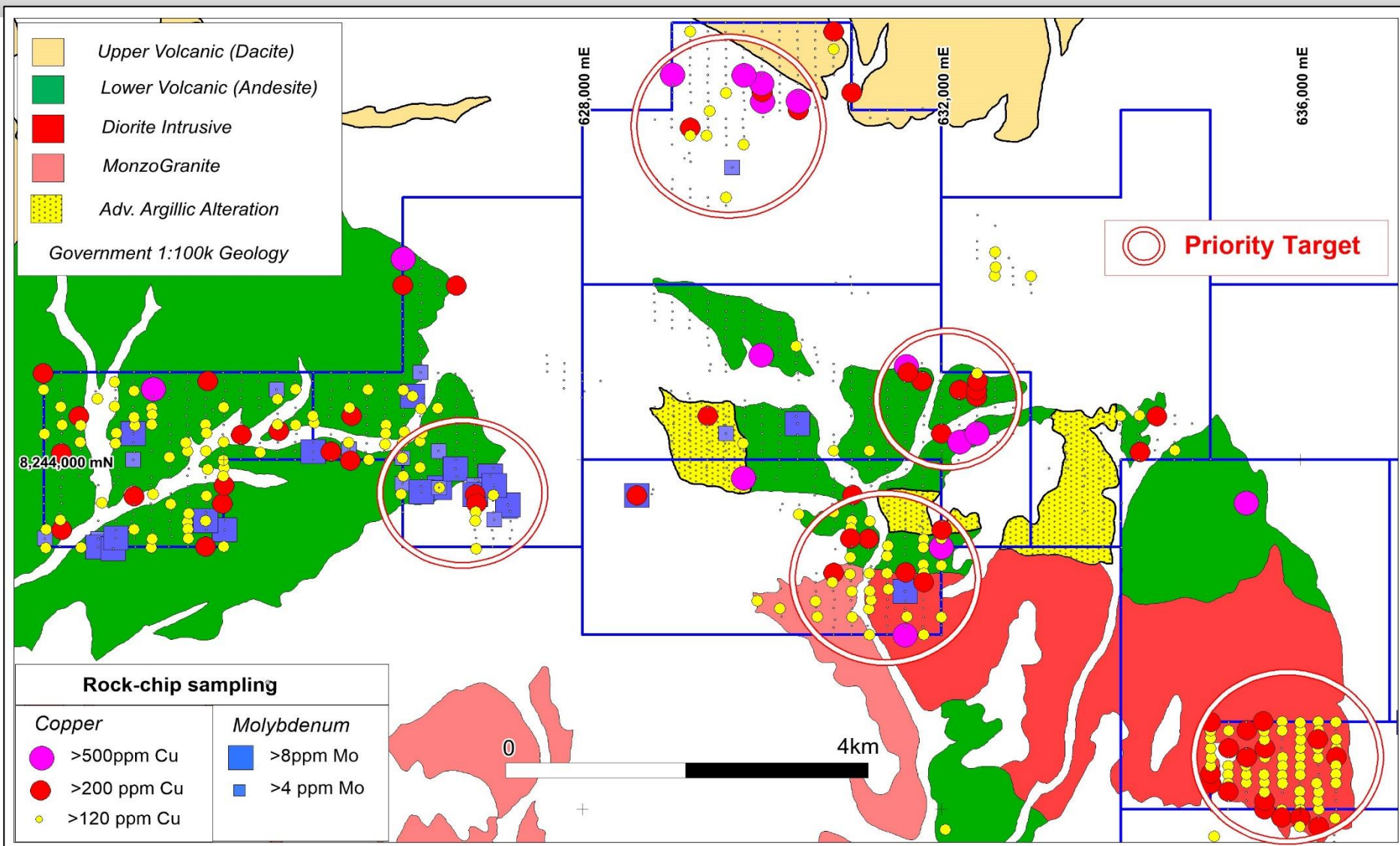
- Drilling planned 2021 to test Cu potential between high surface Cu values and drilled intersections – Cu occurs in andesitic volcanics (mantos) & in structures

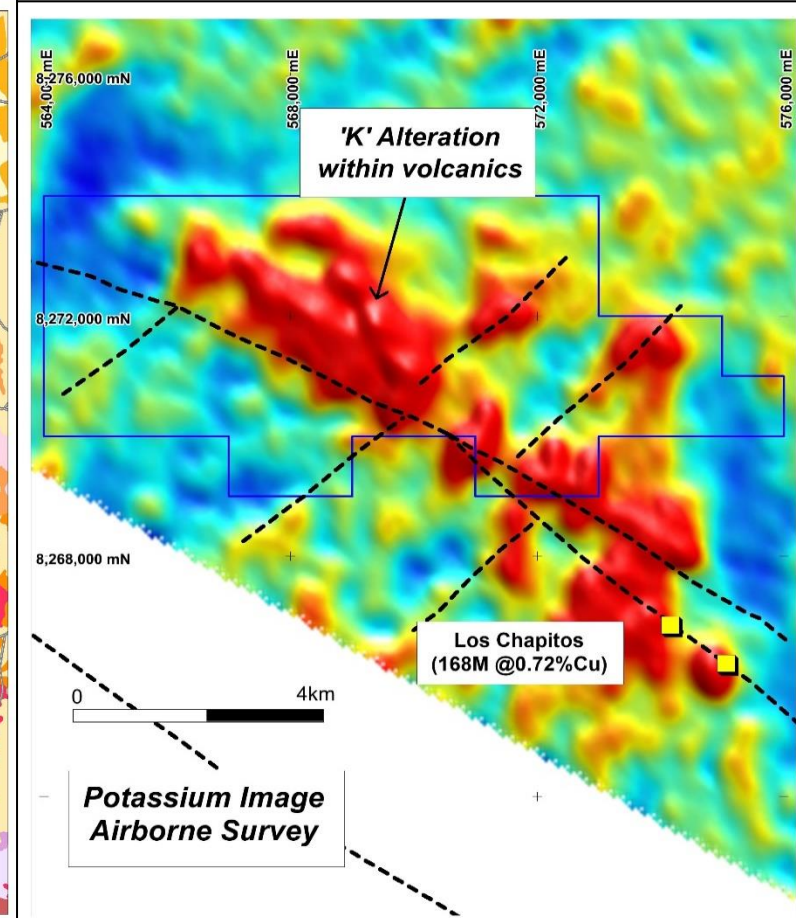
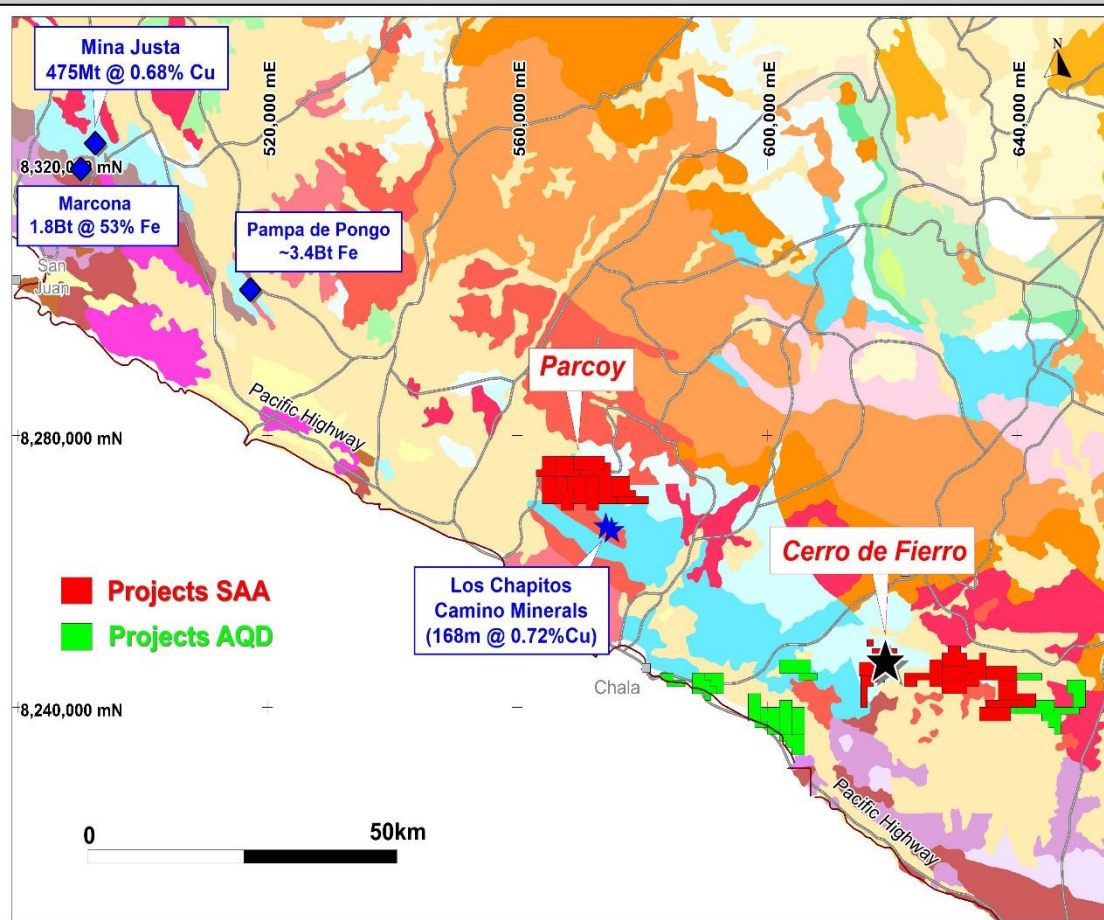
Cryptic surface expression of copper mineralisation – easily missed!

CDF-EAST – New Manto & Porphyry Cu Targets



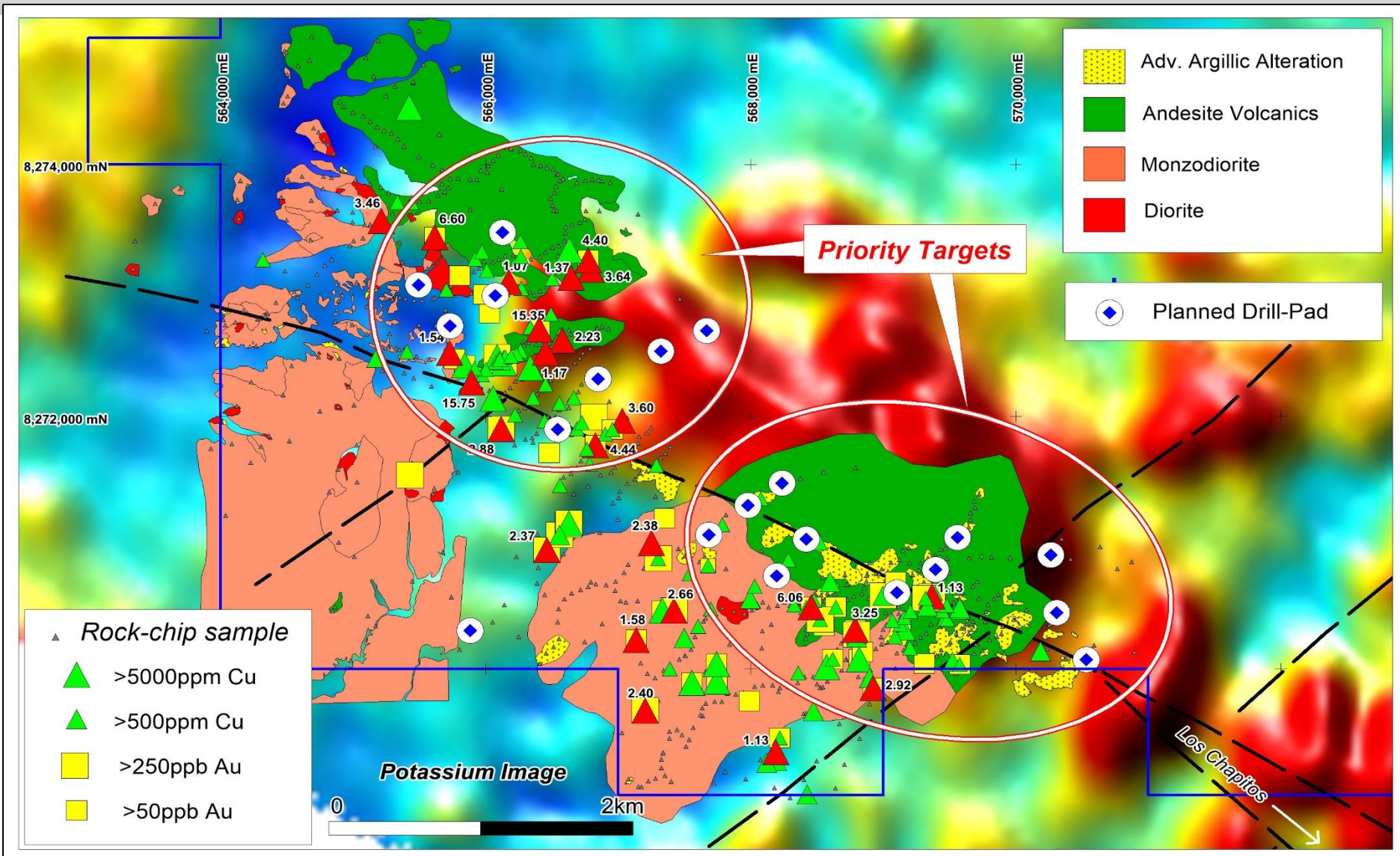
- Surface sampling identifies new Cu-Mo targets over 15km strike, east of Cerro de Fierro

PARCOY – Copper in Known IOCG Belt



- Highly prospective region for IOCG deposits – close to Mina Justa (475Mt @0.68%Cu), & along strike (~6km) Los Chapitos (Camino Minerals – currently drilling)
- Potassic alteration within volcanics, identified by Company's airborne survey, highlighted untested potential for copper-gold manto-style mineralisation

- Cu (+/- Au) defines manto-style targets within K-altered volcanics – drilling 1H 2021
