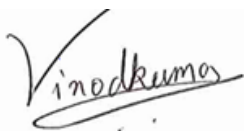

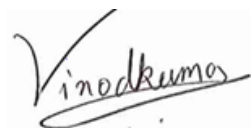

- a) Dilution to existing holders of ordinary shares as a result of the proposed issue made under ASX Listing Rule 7.1A.

The Company proposed the issue of 18,028,439 ordinary shares under 7.1A. The existing holders of ordinary shares before the issue under Listing Rule 7.1A will own 96.10% of issued capital following the proposed issue under Listing Rule 7.1A.
