Notice Under Section 708A(5) of the Corporations Act 2001

This notice is given by Argent Minerals Limited ("the Company") in relation to the issue of 1,000,000 fully paid ordinary shares issued on the conversion of 1,000,000 unlisted \$0.031 options exercisable on or before 27 October 2022 detailed in the appendix 2A announced on 9 February 2021.
