On 2 December 2008, Administrators were appointed to assume control of the Company. On 15 April 2009, the creditors of the Company approved the Administrators entering into a Deed of Company Arrangement (DoCA) to investigate the restructure of the Company's capital. On 23 November 2011, shareholders approved a proposal for the restructure and recapitalisation of the Company which resulted in the syndicate behind the proposal paying \$630,000 (on behalf of the Company) to the Deed Administrator for the purposes of satisfying all creditor claims, liabilities and obligations of the Company being compromised under the DoCA. The Company repaid the syndicate upon the completion of the capital raising.
