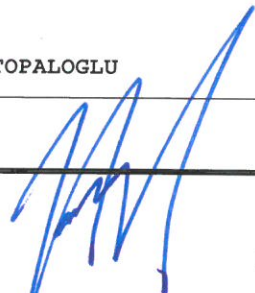

DIRECTIONS
