YOUR OPTIONS TO ACQUIRE ANSON RESOURCES LIMITED SHARES AT \$0.025 PER SHARE EXPIRE ON 10 AUGUST 2018

We are writing to you as a registered holder of 10 August 2018 options in Anson Resources Limited to remind you that the options will expire at 5:00pm (WST) on 10 August 2018.

Your option holding may be exercised in whole or in part by payment of \$0.025 for each option by no later than 10 August 2018. If payment is not received by 5:00pm (WST) on 10 August 2018 the options will lapse and all rights under the options will cease at that time.

Some of the courses of action available to you as a holder of these soon to expire options are:

- a) Exercise the options on or before 10 August 2018.
- b) Sell your options. Quotation of the options on ASX will cease at the close of trading on Monday, 6 August 2018.
- c) Do nothing (i.e. allow your options to expire). If you do not exercise or sell your options they will expire on 10 August 2018 and your right to subscribe for ordinary shares in Anson Resources Limited at \$0.025 per share will lapse.
