PLACEMENT

Ausgold Limited (“Ausgold” or the “Company”) advises that the Company has today completed a Placement of 21,000,000 ordinary fully paid shares at an issue price of 5 cents each, raising \$1,050,000 before costs. Allotment of the placement shares will occur on Tuesday 26 July 2016. An Appendix 3B is attached.

The Placement was made pursuant to Section 708 of the Corporations Act 2001 (Cth) (Act) and in accordance with Listing Rule 7.1 of the ASX Listing Rules.

USE OF FUNDS

The proceeds of the Placement will be used to accelerate the Company’s exploration and resource development programmes at the KGP and to provide additional working capital.

Work has been ongoing on target generation for the next phase of exploration at the Katanning Gold Project (KGP) to increase the chance of new discovery and increase gold resources on the Company’s tenements, by utilisation of the outcomes of the studies of the historic data/information and expertise.

The geological, geochemical and geophysical characteristics of the KGP highlight the region as a significantly under-explored Archaean Greenstone Belt; combined with the structural setting and Ausgold’s dominant landholding, provides excellent discovery potential.

During the coming months, Ausgold plans to complete a maiden RC drilling program at the Datatine prospect to follow up on its recent discovery; with the aim of expanding the known mineralisation. The Placement funding also allows Ausgold to undertake an aeromagnetic (geophysical) survey across the Company’s regional tenements at Katanning, with the objective of identifying further drill targets.
