Value of Return of Capital and Reduction in Exercise Price of Options

Value of Capital Return

The Company refers to an in specie distribution of 16 million Alara Uranium Limited (**Alara**) shares (**In Specie Distribution**) to be effected by the Company undertaking an equal reduction of share capital (**Capital Return**), which was approved by shareholders at the recent 2007 Annual General Meeting.

The In Specie Distribution was effected by the transfer of 16 million Alara shares to eligible Strike shareholders on 13 December 2007 (**In Specie Distribution Date**).

The value of the Capital Return is calculated by reference to the market value of Alara shares on the In Specie Distribution Date, which was 12.0 cents per share, making the total value of the Capital Return \$1,920,000 or 2.2 cents per Strike share.

The table below provides illustrations of the number of Alara shares distributed in specie and the value of the Capital Return based on different Strike shareholdings held as at the record date (on 10 December 2007):

Reduction in Exercise Price of Options

The Capital Return will also have the effect of reducing the exercise price of existing Strike options which remain unexercised after the record date by the value of the value of the Capital Return per Strike share.
