SHARE PURCHASE PLAN OFFER EXTENDED

Resource and Investment NL (ASX: **RNI**) (**RNI** or **the Company**) advises that the closing date for the Company's Share Purchase Plan (SPP) Offer has been extended to 5.00pm (Perth time) on Friday 30 May 2014.

The SPP entitles eligible shareholders to purchase up to \$15,000 worth of fully paid ordinary shares in the Company at an issue price of 7.5 cents per share.

As mentioned in the Company's Section 708A Notice announced to the ASX on 5 May 2014, the Company is awaiting laboratory assay results from recent diamond drilling at the Forrest-Gimp copper-gold discovery and has received requests from a number of shareholders for additional time to assess the SPP Offer. Consequently, the closing date has been extended to give eligible shareholders additional time to consider and take advantage of the SPP Offer.
