Completion of Placement

Further to the announcement on 17 August 2009, the Company advises that the placement of 15,500,000 ordinary fully paid shares (**Shares**) at an issue price of \$0.039 per Share, together with 15,500,000 free attaching options exercisable at \$0.07 each on or before 30 September 2012 (**Options**), has been completed.

The placement was made under the Company's 15% placement capacity, as allowed under the ASX Listing Rules, and made to sophisticated investors pursuant to section 708 of the Corporations Act.
