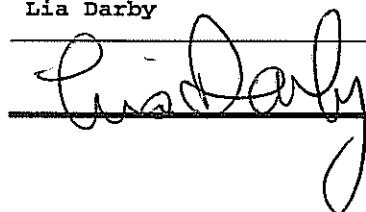

DIRECTIONS

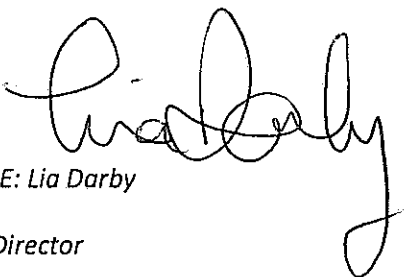
