APPENDIX 4C – QUARTERLY CASH FLOW REPORT – JUNE 2017

Adelaide, Australia, Monday 31 July 2017: Axiom Properties Limited (ASX:AXI) lodges the attached Appendix 4C Quarterly report for entities admitted on the basis of commitments for the quarter ended 30 June 2017.

Commentary is provided as follows:

- The Company held cash reserves of \$1.984 million at 30 June 2017.
- The Company's cash reserves for the June quarter decreased by \$180,785 as follows:
 - o Net operating cash outflows for the June quarter were \$178,096.
 - o Net investing cash flows for the June quarter were \$2,689.
 - o Nil financing cash outflows for the June quarter.

The Company continued to invest in the development of its Mt Barker land sub-division during the quarter and generally in its property portfolio including its Double Bay project in Sydney.

The Company invested costs into the process of securing the recently announced Currie Street Joint Venture and Richmond NSW land purchase, as well as incurring costs associated with successfully exercising its option to enter into a Sales Contract for Churchill South Retail Centre. Net proceeds from the sale in excess of \$10m are expected to be received in the following reporting quarter.
