**ALLOTMENT AND ISSUE OF SHARES ON CONVERSION OF CONVERTIBLE LOAN NOTE**

We are pleased to advise that Retirewise Capital Australia Pty Ltd ("**Retirewise**") has elected to convert \$150,000 of their convertible loan notes into ordinary shares in the Company at a strike price of 6 cents per share.

The agreement with Retirewise also provides for them to exercise the right to subscribe for shares as if they had participated in any rights issue since the date of the convertible loan notes. The Deed under which the convertible loan notes were issued was approved by shareholders in a meeting held on 26 August 1997.

The conversion of their convertible loan note with a value of \$150,000 allows them to acquire 2,500,000 ordinary fully paid shares in the Company. Further, the Company in 1998 had a rights issue of 1 for 6 at 6.5 cents which allows Retirewise to apply for shares under that rights issue for 416,667 shares for a total of \$27,083.36. In early 2004 the Company also had a rights issue of 1 for 2 at 8 cents which also now permits Retirewise to apply for 1,458,334 shares for a total of \$116,666.72.

Consequently, today the Directors of the Company have allotted and issued a total of 4,375,001 ordinary fully paid shares in the Company to Retirewise for a total consideration of \$293,750.08. Retirewise has requested that the application money not related to the reduction in this convertible loan note be applied against the working capital loan which the Company had from Retirewise with the minor remainder paid in cash. The latter loan has now been extinguished in full and all outstanding interest paid as well. The balance of the convertible loan note still held by Retirewise is today, after the above allotment and issue of shares \$150,000.

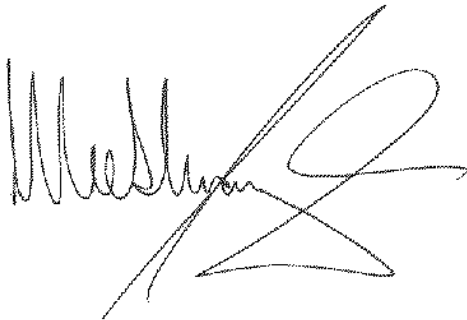
