DIRECTIONS

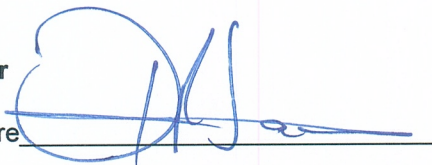
