### **Drilling Scheduled at Copper Blow**

- **Silver City schedules second round of drilling at Copper Blow commencing December**
- **Targets are depth extension of high grade copper-gold-cobalt drill intersections**
- **Metallurgical testwork to commence for both cobalt and copper-gold recoveries**

**Silver City Minerals Limited (ASX: SCL) (“Silver City” or “the Company”)** is pleased to announce that it plans to commence a diamond drilling program at the Copper Blow project located 20 kilometres south of Broken Hill (Figure 4).

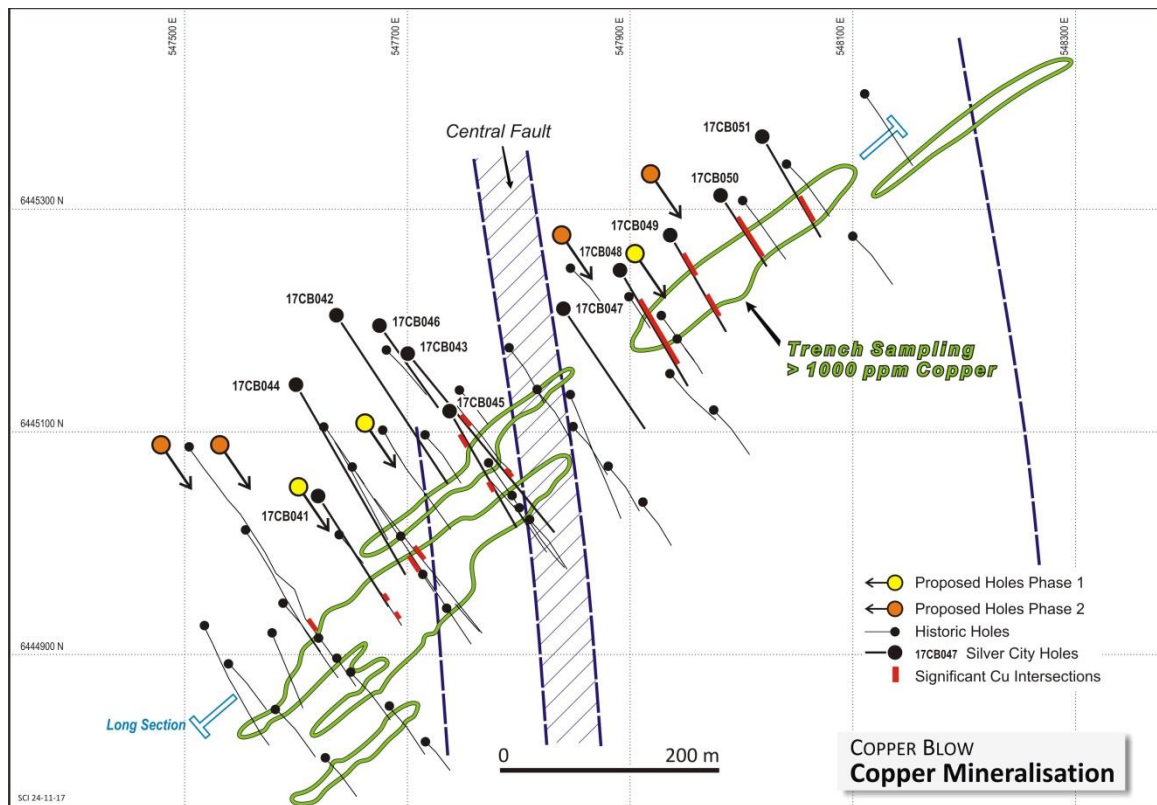
In recent ASX announcements the Company has presented results of drilling and geophysical surveys. These have been very encouraging with a number of high quality follow-up targets immediately evident for further drill testing.

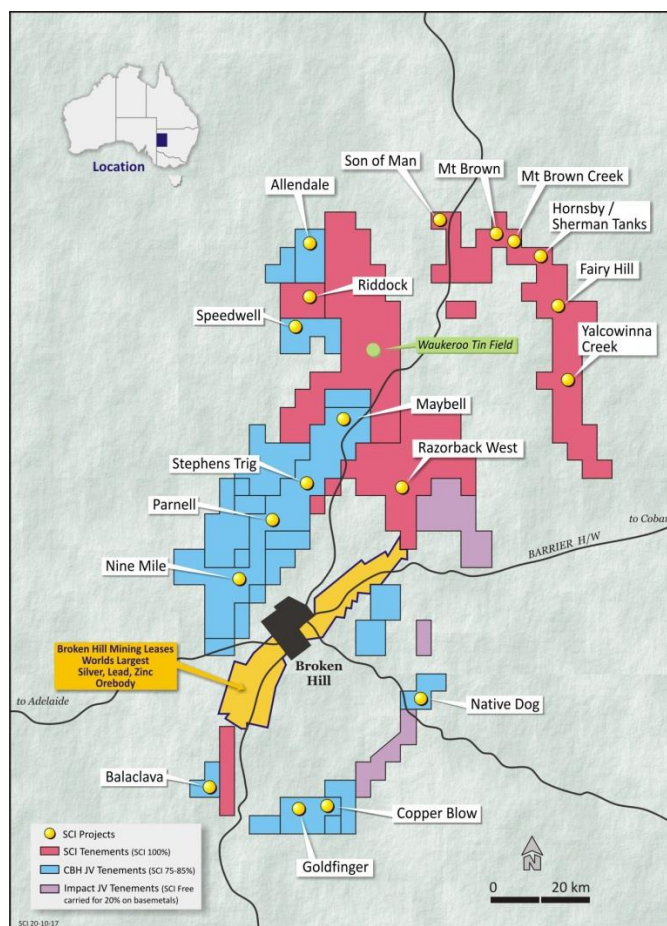
**Figure 1.** Copper Blow drill hole locations with significant mineralisation represented as red bars on drill traces. Central Fault separates high grade and deeper mineralisation in the south from broad zones of lower grade in the north.

Silver City will allocate existing funds to a follow-up program of three holes for a total of approximately 850 metres (Phase 1). This drilling will target the interpreted extensions to known high grade mineralisation over a down plunge distance of 200 metres (Figures 1 and 2). In addition the Company will commence exploratory metallurgical testing on mineralised rock from recent drilling in order to determine the characteristics and recoverability of copper, gold and cobalt.

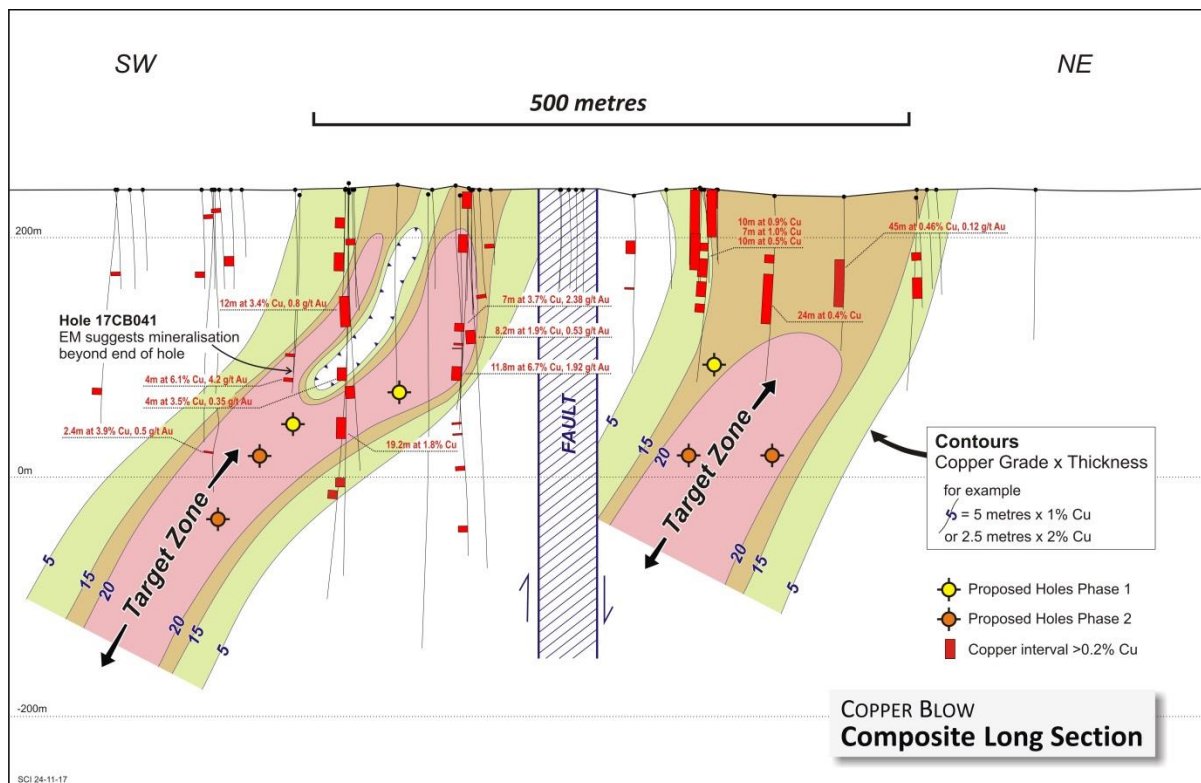
Subject to environmental permitting and site access arrangements the Company envisages commencement of Phase 1 in December 2017.

A second follow-up program, contingent on results of the first, is also planned (Phase 2). It will not only test deeper extensions of mineralisation at Copper Blow but will test two geophysical anomalies to the northeast of Copper Blow. These are significant coincident magnetic and gravity highs beneath old mine workings. SCL rock chip sampling has returned anomalous results with up to 0.3% copper from the northernmost anomaly.

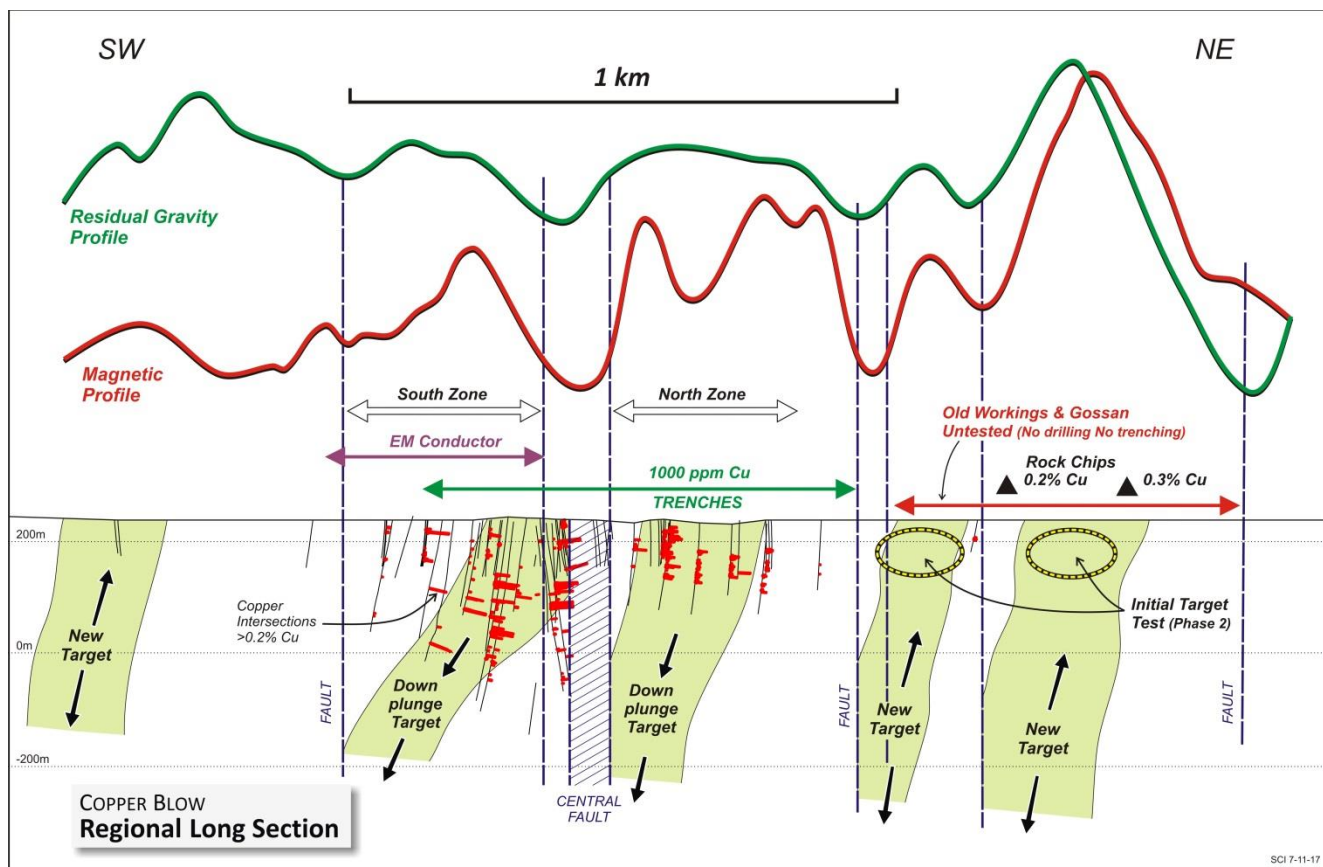
The details of Phase 2 are yet to be finalised, however the Company envisages a drilling program (combined reverse circulation and diamond) would be between 4000 and 6000 metres.
