Simple corporate bonds called, Series B Australian Unity Bonds - Tranche 1, ("Bonds"), which are 5 years, unsecured debt securities issued by the Issuer, under an offer specific prospectus ("Offer Specific Prospectus") and base prospectus ("Base Prospectus") lodged with the Australian Securities and Investments Commission ("ASIC") on 9 November 2015 and with the Australian Securities Exchange ("ASX") on that same day. The Offer Specific Prospectus was replaced by a replacement Offer Specific Prospectus ("replacement Offer Specific Prospectus") lodged with ASIC on 17 November 2015 and the ASX on that same day.
