**Beforepay Group Limited Q4 FY25 Quarterly Activities and Appendix 4C Cash Flow Report
(Unaudited)****Beforepay achieves record Q4 profitability and accelerates Carrington Labs**

Beforepay Group Limited (the Company) (ASX: B4P) has released its Quarterly Activities and Appendix 4C for the quarter ended 30 June 2025 (Q4 FY25).

Beforepay Group CEO, Jamie Twiss said, “This quarter’s result marks another milestone for the Group, with a significant increase in profitability, continued strong growth, and a series of client and partnership announcements for Carrington Labs. I couldn’t be happier with this result; it’s the perfect way to end a strong financial year.”

Q4 FY25 Business Update

- **Profitability:** The Company achieved a quarterly net profit before tax (NPBT) of \$2.4m, up 76% on the Q4 FY24 figure of \$1.4m, and up 113% from the previous quarter.
- **Revenue:** Revenue increased to \$10.4m, up 15% YoY (year-on-year or YoY).
- **Active users:** Increased 12% YoY to 269,558.
- **Advances:** Quarterly advances reached \$210.1m, up 18% on Q4 FY24, driven by a 13% increase in the number of advances to 539,000, while the average advance size increased by 4% to \$390.
- **Net defaults:** Improved significantly to 0.56%, down from 1.24% in Q4 FY24, reflecting continued enhancements to the credit model and limit management. The extremely low default rate in Q4 is expected to revert to normal levels over time.
- **Net transaction margin (NTM):** Increased to \$7.7m in the quarter, up 48% YoY from \$5.2m in Q4 FY24. This result was driven by higher advance volumes and lower defaults.
- **Operating expenses:** Rose to \$5.0m from \$4.4m in the prior quarter, reflecting the Company’s strong operating leverage and continued targeted investment in our strategic growth initiatives.
- **Balance Sheet:** The Company maintained a strong balance sheet with an equity balance of \$40.3m and “Total Cash” of \$19.2m as at Q4 FY25 (down from \$28.9m in Q3 FY25). “Total Cash” comprises \$14.0m of cash-at-bank and \$5.2m of cash held in our funding and settlement accounts. The change in cash position from Q3 has been driven primarily by the repayment of \$7.5m of debt, as well as the timing of advances and repayments.
- **Debt Facility:** On 17 April 2025, the Company’s wholly owned subsidiary, Beforepay Finance

Pty Ltd, introduced a \$7.5m revolving sub-limit within the existing \$55m facility limit. This revolving sub-facility enables the Company to more efficiently manage its overall funding costs by deploying excess cash when available. As at 30 June 2025, the Company has drawn \$30.9m (\$24.1m undrawn) under its third-party debt facility.

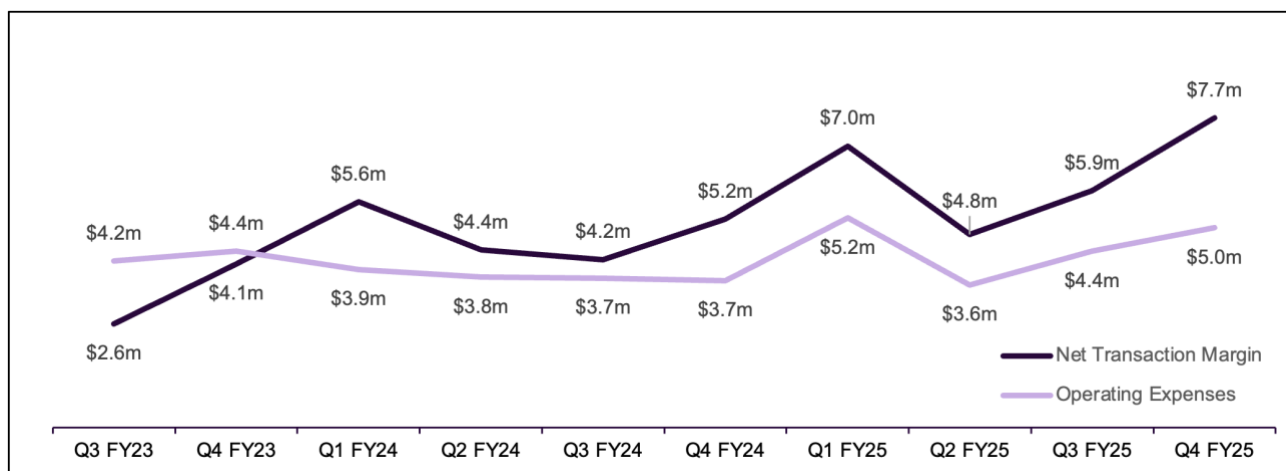
- **Carrington Labs:** Announced a new banking client in the United States, Utah-based CCBank. Following the end of the quarter, it also announced a new U.S. specialty lender, Doc2Doc. Additionally, it has secured new strategic partnerships with two market-leading risk-decisioning platforms, Oscilar and Taktile, enabling their clients to use the Carrington Labs product, and LendAPI, a leading origination platform, creating potential network effects. Combined, these developments represent a meaningful step forward in executing the Company's U.S. growth strategy, underpinned by the region's scale, technological maturity, and strong demand for advanced, data-driven financial solutions.
- **Personal Loans:** The Company continues to issue Personal Loans and has begun gradually to open the product to more existing customers and to increase volumes. Total volumes are not material to the overall Group.
- Q1 FY26 trading to date has been in line with expectations and seasonal trends.

On 18 October 2023, Beforepay Finance Pty Ltd, a subsidiary of Beforepay Group Ltd, signed a secured debt facility agreement for A\$55 million with Australian Commercial Mortgage Corporation Pty Ltd as trustee for the Australian AB Finance Trust (Balmain Group) and AMAL Security Services Pty Ltd as trustee for LCI Funding Trust 1 (Longreach Lender). - The key terms of the facility agreement include: - A\$55 million facility (A\$20 million from Longreach Lender and A\$35 million from Balmain Group) for 3 years to 15 October 2026 with the potential to extend the total facility size in a future period. This reflects a transfer of debt on 29 November 2024, where Balmain Group and Longreach Lender reached commercial agreement to assign a A\$15 million of Longreach Lender's drawn exposure to Balmain Group. - The maximum commitment increases in non-linear increments over time to \$55 million by 14 October 2026. - Borrowing base broadly equal to 80% of the value of eligible receivables. - Interest rate - 12.25% to 13.25%, depending on a fixed charge coverage ratio (FCCR) linked to an EBITDA financial performance measure. - Upfront fees and costs of c. 1.7% on the A\$55 million balance. - On 17 April 2025, Beforepay Finance Pty Ltd, repaid \$7.5 million under the newly signed revolving credit sub-limit within the existing \$20 million Facility B (provided by Balmain Group), forming part of the Company's total \$55 million debt facility, which results in a \$50,000 per month saving in interest costs. - Key commercial terms of the amendment include: - Establishment of a A\$7.5 million revolving sub-limit within the existing A\$20 million Facility B; - An unused line fee of 2.75% per annum on the undrawn portion of the revolving facility; and - No change to the total commitment under Facility B, the overall A\$55 million facility limit or the maturity date under the Agreement. - Financing facilities available at quarter end are subject to meeting the borrowing base test under the facility agreement.
