CBG Fund Details as at 30 June 2019

As at 30 June 2019, Bentley had ~\$0.843 million (13.8% of its net assets) invested in the Clime CBG Australian Equities Fund (Wholesale) (**CBG Fund**) (31 May 2019: ~\$0.84 million (12.1%)).

About the CBG Fund

The monthly performance of the CBG Fund for June 2019 was +1.2% (31 May 2019: +1.2% compared with its benchmark performance (S&P/ASX 200 Accumulation Index) of +3.7% (31 May 2019: +1.7%).

The CBG Fund is a wholesale fund not open to retail investors. The objective of the fund is to outperform the S&P/ASX 200 Accumulation Index over the medium term. The Investment Manager is 'style neutral' and invests in growth stocks, value stocks, stocks with maintainable dividend yields and special situations.

CBG Fund details as at 30 June 2019:

- The equity weighting was 81.5% (31 May 2019: 86.1%)
- 70.2% of the equity portfolio is invested in companies contained within the S&P/ASX 200 Index (31 May 2019: 72.6%) with the balance of 29.8% invested in companies outside of the S&P/ASX 200 Index (31 May 2019: 27.4%); and
- The equity portfolio contained 31 holdings (31 May 2019: 29 holdings).
