NEW ISSUE ANNOUNCEMENT

The Company is pleased to announce that, it has today allotted and issued 98,078,690 New Shares and 98,078,690 attaching Options under the Renounceable Rights Issue Offer as announced on 10 May 2018.

Following a high interest on the recently announced Renounceable Rights Issue, the Company today allotted a further 12,007,777 Shares and 12,007,777 attaching Options under a Share Placement Offer. The Placement Offer was undertaken under the same terms as the Renounceable Rights Issue with an issue price of \$0.015 per share and a attaching listed option, raising \$180,116 (before costs). The options have a strike price of 5 cents and expire on 12 December 2019.

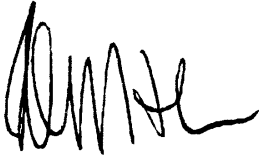
In addition, the Company also issued 6 million options to CPS Capital Group Pty Ltd or its nominees in accordance to the mandate to act as the Lead Manager and Underwriter for the Renounceable Rights Issue. The options are issued under the same terms as those offered under the Renounceable Rights Issue.

1. The shares will be issued under a placement without disclosure to investors under Part 6D.2 of the Corporations Act.

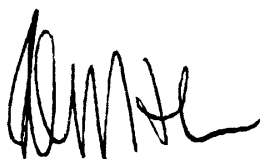
