Cleansing Notice - NOTICE UNDER SECTION 708A(5)(e) OF THE CORPORATIONS Act

Tanzanian graphite developer **Black Rock Mining (ASX:BKT)** ("Black Rock or the "Company") confirms that on 13 November 2017 it completed the issue of 70,000,000 fully paid ordinary shares in the capital of the Company. The Shares were allotted pursuant to the ASX announcement on 6 November 2017.
