

MARKET UPDATE FOR QUARTER ENDED 30 SEPTEMBER 2024

BauMart Holdings Limited (ASX: BMH) (“BauMart” or the “Company”) provides the following operational update along with the Appendix 4C for the quarter ended 30 September 2024.

Group Operations and Commentary on Appendix 4C

- During the September quarter, the Company recovered \$389k from doubtful debts which had previously been provisioned for.

Mining and Construction Services

- The Company has bought back mining equipment previously sold, and is in active discussion with a mining development company on potential longer term wet-hire contract to service their planned development requirements.
- The Company’s Executive Director, Ms Agata Dharma, was actively attending trade shows and as a result the Company has engaged with a local Australian partner to promote mining and construction services working together with indigenous corporations, targeting medium-sized mining companies.
- The Company continues to identify partnership opportunities to provide building material solutions to construction companies in the commercial property development sector.

Washpod Division

- No sales were recorded during the quarter. The Company continues to focus on industrial product distribution locally, interstate and overseas.

Related Party Payments and Other Overheads

- Payments to Related Parties totalled \$23K for the September quarter, comprised of directors’ remuneration.
- Other operating overheads during the September quarter were largely in line with management expectations.
- The Company continues to manage overhead costs to enable the Company to better fund future orders of mining equipment and forecasted costs associated with the assessment and development of new business and investment activities.
