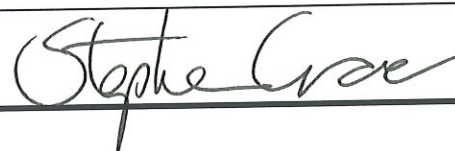

DIRECTIONS
