**SECONDARY TRADING NOTICE PURSUANT TO SECTION 708A(5) OF THE CORPORATIONS ACT 2001
("Act")**

On 12 August 2022, Brookside Energy Limited (**Company**) issued 1,000,000 fully paid ordinary shares in the capital of the Company (**Shares**) in consideration for services provided to the Company.

The Act restricts the on-sale of securities issued without disclosure, unless the sale is exempt under section 708 or 708A of the Act. By giving this notice, the on sale of the Shares noted above will fall within the exemption in section 708A(5) of the Act.

 - (A) The assets and liabilities, financial position and performance, profits and losses and prospects of the Company; or
 - (B) The rights and liabilities attaching to the Shares.
