**SECONDARY TRADING NOTICE PURSUANT TO SECTION 708A(5) OF THE CORPORATIONS ACT 2001
("Act")**

On 6 August 2026, Brookside Energy Limited (**Company**) issued 120,000 fully paid ordinary shares in the capital of the Company (**Shares**) in consideration for corporate advisory services provided to the Company by Cumulus Wealth.
