Brambles Limited: Appendix 2A

Please find attached an Appendix 2A relating to 50,322 ordinary shares in Brambles Limited which have been issued as a consequence of the vesting of matched share rights under the Brambles Limited MyShare Plan to former employees classified as “good leavers” under that plan and the exercise of share awards under the Brambles Limited Performance Share Plan. (Please note that 258 unlisted matched share rights granted under the Brambles Limited MyShare Plan have lapsed since the lodgement by Brambles of the Appendix 2A on 10 September 2020.)

The number of securities referred to in item 5.1 of the attached application takes into account the 869,688 fully paid ordinary shares in Brambles which have been cancelled as a result of the shares bought back from 9 September¹ up to 10 September 2020. A copy of the notice of cancellation of shares arising from that buy-back will be provided to the ASX in accordance with Listing Rule 3.8A.
