Automated Multi Head Filler Reaches 25,000 Units

19 November 2024 – Cann Group Limited (CAN:ASX) is pleased to announce that following the commissioning of its new multi-head filler in August this year, Cann has now completed ~25,000 units packed. Of these, 17,500 (~70%) have been for external customers. The remaining ~30% for Cann's own Botanitech range.

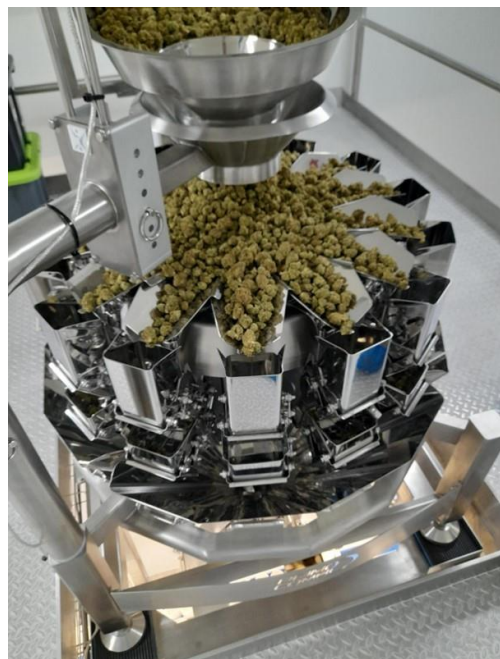
Cann offers a variety of contract GMP services (packing, testing, manufacturing) at its GMP licensed facility in regional Victoria, which provided a meaningful revenue for FY2024 of \$1.2 million. The commissioning of its automated multi head filler gives Cann an unique opportunity in the market to provide competitively priced filling and labelling of medicinal cannabis products with quick turn-around times.

The installation and operation of the MHF is one of numerous efficiency activities undertaken by Cann over the past 8 months. This has resulted in reduction in the operational costs. For example, the MHF reduces the labour costs to filling by ~90%.

About Cann's Contract Packing Services

Cann leverages its GMP licenced facility near Mildura, Victoria to provide contract biomass packing with both hand fill and mechanical fill capabilities:

- Mechanical capability utilising 14-head automatic filling system for flower with Pre-CheQ weight analyser for high accuracy.
- Validated for multi jar sizes and capping with induction seals.
- In house batch printing and jar labelling capability.
- 3 x jar size options (10g, 15g, 28g).
- Capability for up to 9,000 units in single shift.
- Labour efficiencies are significant – approximately 88 less hours on a 9,000 unit manufacture run compared to manual packing.





Cann's CEO & Managing Director, Jenni Pilcher, commented, "The implementation of the multi head filler is another key milestone in our plans to accelerate revenue growth and reduce overheads. Also, we can better support our customers by reducing our turn-around times."
