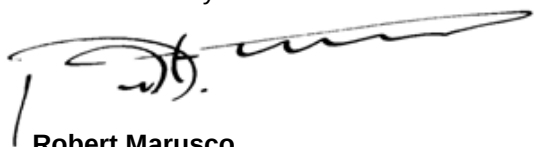
NOTIFICATION UNDER SECTION 708A(5)(E)

On 9 January 2017 Canyon Resources Limited ("CAY" or "the Company") issued 14,212,148 fully paid Ordinary Shares. These Shares were included in an Appendix 3B announcement to the Australian Stock Exchange ("ASX") lodged on 9 January 2017.
