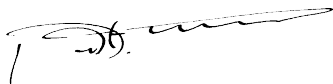
NOTIFICATION UNDER SECTION 708A(5)(E)

On 27 September 2018 Canyon Resources Limited ("CAY" or "the Company") issued 12,725,001 fully paid Ordinary Shares. These Shares were included in an Appendix 3B announcement to the Australian Stock Exchange ("ASX") lodged on 27 September 2018.
