Cobre Limited (ASX: **CBE**, **Cobre** or **Company**) advises that on 18 December 2020, as approved by shareholders pursuant to resolution 5 at the Company's Annual General Meeting held on 26 November 2020, it issued a total of 1,550,000 new fully paid ordinary shares (**Shares**) in the Company at an issue price of \$0.20 each.
