Notice under section 708(5)(e) of the *Corporations Act 2001* (Cth)

This notice is given by Credit Clear Limited (ASX:CCR) (ACN 604 797 033) (the **Company**) under section 708A(5)(e) of the *Corporations Act 2001* (Cth) (the **Act**).

On 28 January 2026, the Company issued 32,000,000 fully paid ordinary shares (**Shares**) for \$0.25 per share to a Director of the Company (the **Investor**) under the Placement announced on 22 October 2025 and subsequently approved at the general meeting held on 27 January 2026.
