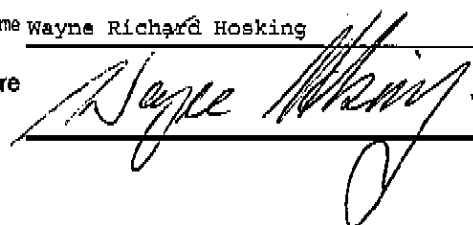

DIRECTIONS

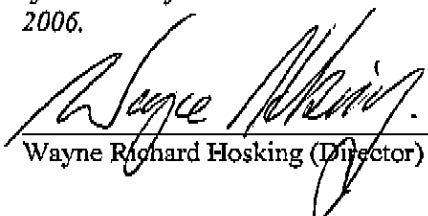

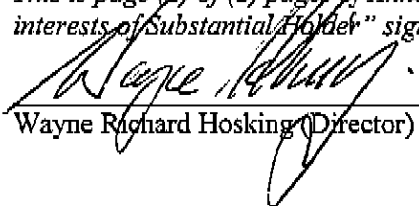

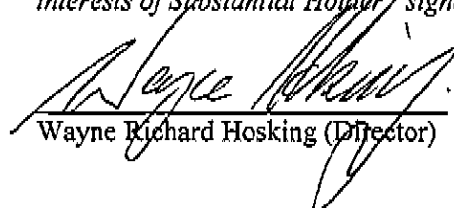
