Highlights

- **Advanced the strategic review of the Company's project portfolio**
- **Potential project acquisitions evaluated and assessed that have the potential to be value-accretive for shareholders**

Codrus Minerals Limited (ASX:CDR) ("Codrus" or "the Company") is pleased to provide an update on activities for the period ended 30 June 2026 ("June Quarter" or "Quarter") across its exploration portfolio, which includes gold, copper, rare earth and uranium assets located in the United States, Australia and Canada.

Potential Acquisition and Growth Opportunities

During the quarter, the Company did not undertake any field exploration activities across its project portfolio. Instead, efforts were centred on internal technical reviews, strategic planning, and prudent capital management initiatives designed to strengthen the Company's operational readiness and position it for future exploration success and sustainable growth.

Supported by the Executive Chairman, Board of Directors, and existing stakeholders, the Company focused its resources on assessing prospective projects and strategic partnership opportunities that offer significant exploration upside and attractive long-term growth potential. No transactions were completed during the period, and the Company continued to actively engaged in identifying and evaluating opportunities with the potential to enhance shareholder value.

Bull Run Gold Project – Oregon, USA

Following completion of the 2025 reconnaissance drilling program, the Company has continued to review results and refine its geological understanding of the project.

- **High-grade molybdenum assays up to 4.2% Mo at Bull Run, reinforcing significant polymetallic upside** (refer to ASX announcement dated 13 May 2025)
 - **Lady May Zone:**
 - **2.5% to 4.2% Molybdenum**, suggesting a valuable polymetallic system
 - **Whited Zone:** 0.8% Molybdenum.
- Rock chip results confirm Mo mineralisation associated with hydrothermal alteration typical of porphyry-related Cu ± Au ± Mo systems, supporting potential for a broader mineralised system.
- Coincident soil Mo anomalies and IP chargeability, suggesting potential for additional Mo mineralisation beyond the Lady May and Whited zones.

- Follow-up field program being designed for Bull Run to advance molybdenum targets toward drill testing.

Bull Run Gold Project Background and Geological Setting

The Bull Run Gold Project (see **Figure 1**) is located in Baker County, eastern Oregon, approximately 5 miles south of Unity. The Project comprises 102 claims, with the Company holding a 100% legal and beneficial interest in 91 claims and being party to the Record Mine Option Agreement with discussions ongoing to extend the agreement over a further 11 claims.

The Project has a history of intermittent vein gold production dating back to ~1929 and is situated within the Ironside Mountain Inlier. The local geology comprises ultramafic-mafic and sedimentary rocks intruded by the Grouse Creek and Bull Run granodiorites, and multiple andesitic to dacite dyke swarms, with widespread porphyry-style alteration and mineralisation recognised in the broader district.

Karloning Rare Earths (Western Australia) - High-Grade Critical Metals Confirmed

The Company has commenced a detailed desktop review of historical data at the Karloning Project in Western Australia, which is guiding the design of an overlimit re-assay program focused on tantalum (Ta) and niobium (Nb) mineralisation.

Initial observations from the review indicate the presence of potentially significant Ta-Nb mineralisation within the broader Karloning system, which has previously demonstrated rare earth element (REE) mineralisation through drilling.

The consistency of historical data is also being assessed as part of the review process, with the aim of improving confidence in the existing dataset.

Karloning Rare Earths Multi-Commodity Critical Minerals System

The ongoing review is supporting the interpretation of Karloning as a prospective multi-commodity pegmatite system. In particular, it is reinforcing a potential link between previously identified shallow clay-hosted REE mineralisation and an underlying pegmatite source that may be enriched in tantalum and niobium.

Previous drilling at Karloning, including approximately 2,000m of RC drilling and ~80 aircore holes, has outlined significant shallow REE mineralisation, supporting the view of a large mineralised system.

This evolving geological interpretation suggests the potential for a vertically integrated mineralised system, encompassing both REE and Ta-Nb mineralisation, subject to further validation.

The **Karloning Project** (see **Figure 2**) is located in the Wheatbelt region of Western Australia and hosts a large, prospective pegmatite system. Historical drilling programs, including Reverse Circulation (RC) and Aircore (AC) drilling, have identified widespread shallow clay-hosted REE mineralisation across the project area.

Jasper Wedge Uranium Project – Saskatchewan, Canada

No field exploration was undertaken at the Jasper Wedge or Nanuk Uranium Projects during the Quarter.

Following the 2024 field program, key findings included:

- **Target Selection:** Targets were identified based on a combination of structural features from historical airborne magnetics and AeroTEM data, gas anomalies detected via Sentinel-2 hyperspectral imaging, and anomalies from a recent UAV magnetics survey.
- **Sampling Overview:** A total of 305 samples were collected across targets JW6A, JW7, and JW10, comprising:
 - 143 soil samples
 - 160 Soil Gas Hydrocarbon (SGH) samples
 - 2 rock chip samples
- **Additional Work:** Geological mapping and reconnaissance were also carried out across other target areas to support ongoing exploration planning.

Jasper Wedge Soil Geochemistry Findings:

- **Uranium Levels:** Soil assays returned uranium values ranging from 1.0 to 2.7ppm U, broadly consistent with, or slightly above, typical Athabasca Basin background levels (~1–2ppm U).¹
- **Masking Elements:** Elevated thorium and vanadium were identified in several samples, which may suppress or obscure uranium anomalism in conventional geochemical interpretation.
- **Anomaly Detection:** Element ratio analysis (including U²/Th) was applied to reduce masking effects, highlighting uranium anomalism and supporting the prospectivity of targets JW6A, JW7 and JW10.

Jasper Wedge Rock Chip Results and Exploration Implications:

- Strongly anomalous uranium rock chips were returned from targets **JW6A** and **JW10**, with results of **5.3ppm U** and **4.6ppm U**, respectively.¹ Samples were collected from radioactive quartz pebble conglomerates and sandstone boulders.
- These results are considered highly encouraging and are consistent with exploration models in the **Eastern Athabasca Basin**, where major deposits such as **Rabbit Lake** and **Key Lake** were historically advanced by tracing radioactive glacial boulder trains.
- The Company will provide further updates as exploration at Jasper Wedge progresses.

The Company continues to assess prior geochemical and geophysical datasets, including anomalism identified in earlier programs, which highlighted prospective uranium targets.

Internal work focused on:

- Refinement of target areas
- Evaluation of exploration methodologies
- Planning for future field programs

Jasper Wedge Background and Geological Setting

The 100% owned Jasper Wedge Uranium Project (see **Figure 3**), MC0016116, covers an area of 2,099 hectares and is located within the world-class Athabasca Basin uranium province in northern Saskatchewan, Canada, approximately 45km south-east of the high-grade Cigar Lake uranium mine, operated by Cameco.²

Along with the Company's **Nanuk Uranium Project** in Quebec, Canada (see **Figure 3**), the Jasper Wedge Uranium Project provides the Company with an exciting opportunity for growth and diversification into the global uranium sector, with these two projects situated in two of Canada's highly prospective, uranium-rich mineral provinces. No exploration was undertaken at the Nanuk Uranium Project during the Quarter.

Corporate Update

As at the end of the Quarter, the Company held A\$198,000 in cash.

The Company maintained a disciplined approach to expenditure during the quarter, with a focus on preserving cash and maintaining operational flexibility.

During the Quarter, the Company disposed of 7,850,000 MOH shares, generating cash proceeds of approximately \$74,000.
