ISSUE OF SECURITIES

Please find attached an Appendix 3B detailing an issue of securities in relation to the acquisition of a 50% interest in Commercial and Industrial Property Pty Ltd (CIP).

As previously announced on 5 June 2007, Charter Hall Group (ASX: CHC) has acquired a 50% interest in CIP for an initial amount of \$40m, comprising \$25m cash and \$15m in CHC scrip (escrowed for 1 - 3 years). An additional consideration is also payable calculated on the average Profit Before Tax for FY07, FY08 and FY09, capped to \$30m.

Charter Hall Group also has a call option to acquire the remaining 50% in CIP, exercisable in July 2010.

We are pleased to announce that the acquisition of the 50% interest in CIP was completed today.

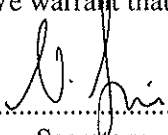
