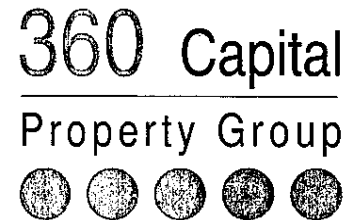

DECEMBER QUARTER 2012 ESTIMATED DISTRIBUTION
