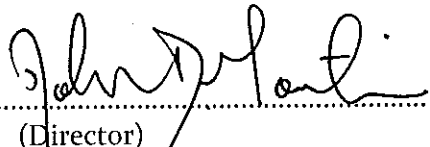

Current Quarter

- 1 – Item 1.1 – receipts cover the slower Christmas period.
- 2 – Item 1.13 – deposits were for the final part of the fit out for the new premises at Pymble.

Year to Date

- 3 – Item 1.2a – staff costs includes one off bonus payments to senior staff for the successful IPO, and part of the outstanding, prior years directors fees that were detailed on page 99 of the IPO Prospectus, dated 5th August 2013. Total \$ 410k.
- 4 – Item 1.6 - R and D Tax Concession FY 2014 – the company estimates it will receive a payment, in Q4 this year of \$3mill. (FY 13 - \$2.3mill).
- 5 – Item 1.13 – Other – this includes deposits have been paid to secure the lease on the new premises \$220k, and for the fit out \$307k. The later is to be funded by a rental agreement that was approved in January 14.
