Cromwell Property Group Performance Rights Plan

Cromwell Property Group (ASX:CMW) has lodged an Appendix 3B advising the market of a change to the number of performance rights issued under the Cromwell Property Group Performance Rights Plan (PRP).

The change follows the exercise of performance rights and consequential issue of 1,016,075 stapled securities. Further, 114,739 performance rights lapsed following the resignation of an employee.
