Non-Renounceable Entitlement Offer – Notification of Shortfall

Baraka Energy & Resources Ltd ("Company" or "Baraka") (ASX:BKP) (FWB:RBD) is pleased to advise that the Company's entitlement offer announced on 17 October 2013 closed at 5:00pm (WST) on 22 November 2013 (Entitlement Issue).

The Entitlement Issue raised \$402,508.56 before issue costs.

The Company's would like to thank the shareholders who participated, with applicants subscribing for 80,501,712 shares representing a take-up of 16%.

The Company expects that the new shares will be allotted and holding statements dispatched to shareholders, on or before 29 November 2013.

The Company has engaged New York Securities Pty Ltd as the Lead Manager and they will use their best endeavours to place the shortfall of 438,412,050 shares.

A shortfall was anticipated by the Board and New York Securities Pty Ltd will now implement their Lead Manager obligations in contacting various brokers, financial institutions and investors throughout Australia, New Zealand, Hong Kong and Singapore and promoting Baraka throughout other countries internationally through a number of different avenues.

Enquiries and discussions are being dealt with by New York Securities Pty Ltd with parties from New York and brokers from Hong Kong, as well as investors and capital providers in Singapore in relation to the shortfall and other considerations for capital.

Looking forward and as previously announced, members of the Board are meeting with Statoil in regards to the Works Program for 2014 in early to mid December 2013.





Further, the Company advises that it has received its refundable R&D tax offset of over \$715,000, as a result of the detailed submission prepared by the Company and lodged with the Australian Taxation Office, and the recovery of loan funds are expected in the first and second quarters of 2014.
