CLEANSING NOTICE

This notice is given by Conico Ltd (**Conico**) under section 708A(5)(e) and 708A(6) of the *Corporations Act 2001* (the **Act**).

On 5 October 2017, Conico issued to investors 2,000,000 fully paid ordinary shares (ASX Code: CNJ) (the **Shares**) following the exercise of 2,000,000 unlisted options.
