PRIVATE PLACEMENT

The Company is pleased to announce it has completed the issue of 1,871,599 shares at PNG kina 0.3386 (approx. 13.19 cents) per share to BSP Capital Ltd in Papua New Guinea. These shares will ultimately be traded on the Port Moresby Stock Exchange (POMSoX).

Coppermoly was listed on POMSoX on 9 December 2008 (code: COY). This small placement is required in order to maintain the Company's listing on POMSoX.

This placement will raise PNG kina 633,723.42 (approx. \$250,000) before costs and will increase the Company's cash balance to approximately \$2,230,000. The funds raised will be used to finance exploration in PNG.

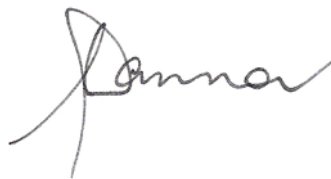
