Force Commodities Ltd (**Force** or the **Company**) (ASX Code: 4CE) is pleased to confirm that it has completed the issue of 5,562,500 fully paid ordinary shares (Shares) in the capital of the Company.

The Shares were issued pursuant to the conversion of 5,562,500 unlisted options, as follows:

- (i) 250,000 options having an exercise price of \$0.032 (i.e. 3.2 cents) per share and with an expiry of 30 June 2019 for \$8,000 received.
- (ii) 5,000,000 options having an exercise price of \$0.035 (i.e. 3.5 cents) per share and with an expiry of 30 June 2019 for \$175,000 received.
- (iii) 312,500 options having an exercise price of \$0.048 (i.e. 4.8 cents) per share and with an expiry of 30 June 2019 for \$15,000 received.

In total, the Company received \$198,000.
