Force Commodities Ltd (**Force** or the **Company**) (ASX Code: 4CE) is pleased to announce that it has completed the issue of the final tranche of 11,500,000 fully paid ordinary shares to the vendor of the Tshipala Project pursuant to ASX Listing Rule 7.1 and as approved by shareholders at a General Meeting of the Company held on 16 August 2019.

As a consequence, the Company has now completed the issue of a total of 40,000,000 fully paid ordinary shares to the vendor of the Tshipala Project, in satisfaction of the condition precedent for the acquisition of an initial 51% interest in the Tshipala Project.

By way of information the acquisition of the initial 51% interest in the Tshipala Project was on the following key commercial terms:
