Chairman's Letter

Dear Shareholders On behalf of the Board, I am pleased to present Cettire's FY22 Annual Report.

FY22 Highlights

The business continued to deliver strong growth in sales revenue and other key growth metrics as we scaled our exceptional technology capability and supply chain with significant marketing investment.

The Group achieved sales revenue of \$210 million, reflecting a year-on-year increase of 127%.

Scale enables the business to form broader and deeper relationships with suppliers, make greater investments in our technology platform and continue to enhance the customer proposition. This in turn fuels our revenue growth.

Our revenue base broadened during the year as we started to grow our presence beyond our established (top 3) markets, being the US, UK and Australia. We also experienced continued strong growth in gross revenue from repeat customers, which now represents around 50% of the total. Repeat customers are transacting with increased frequency and tend to demonstrate materially higher average order values than first time customers.

Investing in technology remained a key priority during the year.

Our highly automated platform is designed to operate globally at scale and is key to achieving our growth objectives. In FY22, the launch of our proprietary storefront has been instrumental in providing additional flexibility and functionality to address our global opportunity. Furthermore, as the majority of traffic on Cettire's platform is on mobile devices, Cettire released its mobile applications during the year, providing greater access to Cettire's online luxury goods offering. It also operates to improve customer experience, while supporting customer engagement, conversion and retention.

FY23 Outlook

Cettire's growth potential is significant. We are still in the early stages of capturing our market opportunity.

The business will continue to increase penetration of established (top 3) markets while continuing to grow strongly in its emerging markets, enabled by the implementation of the proprietary storefront software, supplemented with disciplined marketing investment.

In line with our growth strategy, China continues to represent a significant market opportunity. Cettire's mainland China proposition, in partnership with JD.Com, is expected to launch in FY23.

The development and launch of our beauty category, a further significant market opportunity, also remains a focus in FY23 and will broaden Cettire's product range and customer base, enabling customers to purchase across different luxury categories on a single online platform.

In FY23, Management remains committed to delivering sustainable growth and shareholder value with an increased focus on profitable growth.

I thank the Board, Founder and CEO Dean Mintz and the management team for their contribution over the past year and look forward to building on the successes in the year ahead. Thank you to our shareholders who have also invested in the growth potential of Cettire. I continue to look forward to building long term value as Cettire executes on its strategic objectives.

CEO's Letter

Dear Shareholders, FY22 has been a year of significant further operating momentum.

I and the entire Cettire team believe there is an opportunity to add significant value across the luxury value chain via enhanced application of technology. Cettire's rapid, early-stage growth is reflective of this opportunity. Likewise, the successful injection of capital into the business following our IPO in December 2020, further enabled the pursuit of growth, with sales revenues increasing almost 10x from \$23 million in FY20 to \$210 million in FY22. Whilst we consider Cettire is still early in its journey, our continued momentum reinforces our core belief in the market opportunity.

We have exited FY22 with a business with much stronger foundations:

- Revenue is more diverse across geographic markets and, our emerging markets, representing those outside of our top 3, are showing exceptional early-stage growth;
- Revenue from repeat customers now represents around 50% of our total gross revenue;
- Our supply chain has grown significantly since IPO and we have also continued to expand our direct brand partnerships;
- We now own the technology across the end-to-end customer journey, having launched and migrated traffic to our proprietary storefront software;
- Key commercial supply contracts have been reset, enabling improved unit economics through continued scaling;
- Our team has grown and we continue to attract world class engineering talent; and
- We entered a partnership with JD.Com, providing an attractive entry point into the China market opportunity.

Our strategic priorities remain the same, to enhance our technology platform, expand our product offering and supplier network as well as rapidly drive scale in the core business. There is also considerable scope to grow our addressable market – via adjacencies – over time.

During FY22, we made significant additional investment in our technology platform. The move to our proprietary storefront software should be viewed as a major milestone and I am pleased we have successfully completed the migration of our traffic to the new software. Not only is this purpose-built software a game-changer for the Cettire

platform as it scales, it considerably enhances our flexibility and functionality to support future growth. At the same time, it allows Cettire to effectively localise our proposition, which in turn, enables us to grow penetration outside the top 3 established markets (US, UK and Australia).

The launch of our mobile apps was a further key milestone during the year and we are pleased with the early traction and customer response. The apps provide enhanced user experience and further opportunities to engage and retain our customers.

We continue to experience very strong growth in our supply chain, which is critical in adding depth and breadth to our expanding product base. Specifically, accessible products increased to more than 108,000 as at 30 June 2022. Ongoing expansion of accessible products remains a key priority. Pleasingly, a robust pipeline of supplier relationships, including direct engagement with brands, provides us considerable confidence in our ability to do so.

An additional area of significant investment throughout FY22 was in customer acquisition and brand. We've observed a noticeable step-up in growth outside of our top 3 markets, enabled by the migration to our proprietary storefront. Further penetration of markets outside our top 3 continues to represent a significant incremental growth opportunity for Cettire.

Looking ahead, successfully launching in China and beauty remain focus areas within our growth strategy into FY23. Cettire will continue to place a greater emphasis on profitable growth, noting that we have demonstrated in prior financial years that the business can generate healthy profits when it is operated to do so. We have a nimble and flexible business model with a largely variable cost base and minimal inventory risk. This enables us to adjust quickly to market conditions and optimise performance.

Our progress in the last 12 months could not have been achieved without the efforts of our growing team. On behalf of the Board of Directors and the executive, I wish to acknowledge and thank the team for their dedication and focus.

I would also like to sincerely thank our customers, suppliers, shareholders and all of our partners for their support through the year. While I am pleased with our progress to date, the opportunity ahead of Cettire is tremendous and we are only at the beginning of our journey.

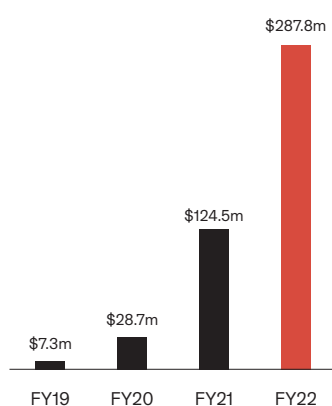

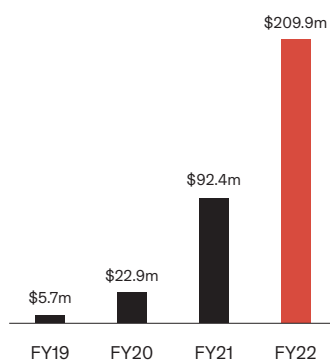

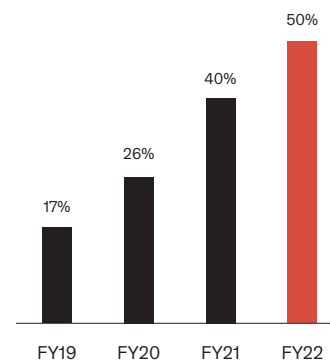
Sales revenue,

127% on FY21



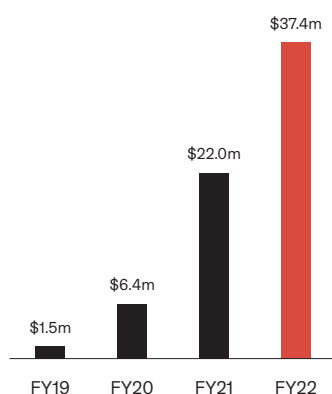
Gross revenue¹



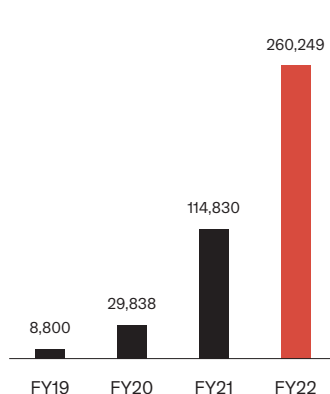
Sales revenue



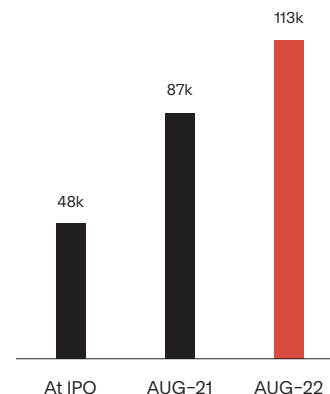
Share of gross revenue from repeat customers

Directors' Report

Your directors present their report on the consolidated entity (the "Group" or "Cettire") consisting of Cettire Limited (the "Parent" or "Parent Entity") and the entities it controlled at the end of, or during, the year ended 30 June 2022.

Principal activities

During the year the principal continuing activities of the Group consisted of online retail sales.

Review of operations

During the year ended 30 June 2022, Cettire achieved several important milestones and delivered strong business results including:

- Sales revenue of \$209.9 million, up 127% on the prior corresponding period ("pcp");
- Active customers growing to 260,249 (127% growth vs pcp);
- 403,420 orders processed, up 137% on the pcp; and
- 50% of gross revenue from returning customers (40% in the pcp).

Financial performance

Sales revenue for the year was \$ 209.9 million (2021: \$92.4 million), an increase of 127% on the pcp. Growth was driven by a combination of customer growth and sales revenue per active customer which increased to \$806 (2021: \$805).

Statutory gross margin increased in the year to \$37.4 million (2021: \$22.0 million), predominantly driven by the growth in revenue. Gross margin percentage has decreased to 17.8% (2021: 23.8%), driven by a higher returns rate and higher fulfilment costs.

Statutory net profit/(loss) after tax for the year was \$(19.1) million, (2021: \$(0.3) million), as the Group invested for further growth.

Financial position

The Group ended the period with a cash balance of \$22.7 million and zero debt (2021: \$47.1 million cash and cash equivalents and zero debt).

The Group generated negative cash flows from operations of \$14.7 million (2021: \$12.7 million surplus), reflecting the investment-driven operating losses, offset by a working capital inflow.

Strategy

Cettire's strategic focus is to grow its core business and to continue to drive the significant growth trajectory the Group has achieved to date. Cettire believes there is an opportunity to significantly increase its share of, and to benefit from further growth in, the personal luxury goods market and the transition to online shopping by building on Cettire's own brand awareness and customer proposition and improving core infrastructure to generate stronger customer and unit economics.

The Group intends to invest across four key channels:

- Increase marketing to enhance brand awareness, increase site traffic and revenue;
- Technical and operational enhancements;
- Expand product offering and supplier network; and
- Other adjacencies, including new markets and categories.

Significant changes in the state of affairs

There were no significant changes in the state of affairs of the Group during the financial period.

Dividends

No dividends were paid or declared during the year (2021: none, with the exception that, as set out in the Prospectus, an unfranked dividend of \$3,305,000 was paid to the sole shareholder prior to the corporate re-organisation and IPO).

Events occurring after balance sheet date

In the opinion of the Directors, there have been no matters or circumstances which have arisen between 30 June 2022 and the date of this report that have significantly affected or may significantly affect the operations of the Group, the results of those operations, or the Group's state of affairs in future financial periods.

Notes to the Financial Statements

30 June 2022

Note 1. General information

The financial statements cover Cettire Limited (the "Group" or "Cettire") as a group consisting of Cettire Limited (the "Parent" or "Parent Entity") and the entities it controlled (as listed in note 32) at the end of, or during, the period. The financial statements are presented in Australian dollars, which is the Group's functional and presentation currency.

Cettire Limited is a company limited by shares, incorporated and domiciled in Australia, with a listing on the Australian Securities Exchange (ASX). Its registered office and principal place of business is:

A description of the nature of the Group's operations and its principal activities are included in the director's report, which is not part of the financial statements.

The financial statements were authorised for issue, in accordance with a resolution of the directors, on 30 August 2022.

Note 2. Significant accounting policies

The principal accounting policies adopted in the preparation of the financial statements are set out either in the respective notes or below. These policies have been consistently applied to all of the years presented, unless otherwise stated.

New or amended Accounting Standards and Interpretations adopted

The Group has adopted all of the new and amended Accounting Standards and Interpretations issued by the Australian Accounting Standards Board ('AASB') that are mandatory for the current reporting period. The adoption of these Accounting Standards and Interpretations has not had a material effect on the Group.

Any new amended Accounting Standards or Interpretations that are not yet mandatory have not been early adopted.

The Group has considered Accounting Standards and Interpretations which have been issued but are not yet effective, identifying the following which are relevant to the consolidated entity:

- AASB 2020-1 Amendments to Australian Accounting Standards – Classification of Liabilities as current or non-current
- AASB 2021-2 Amendments to Australian Accounting Standards – Disclosure of Accounting Policies and Definition of Accounting Estimates

When these amendments are first adopted for the year ending 30 June 2024 there will be no material impact on the financial statements.

Other Accounting Standards and Interpretations which have been issued but are not yet effective are not relevant to the consolidated entity, or their impact is editorial only.

Basis of preparation

These general purpose financial statements have been prepared in accordance with Australian Accounting Standards and Interpretations issued by the Australian Accounting Standards Board ('AASB') and the *Corporations Act 2001*, as appropriate for for-profit oriented entities. These financial statements also comply with International Financial Reporting Standards as issued by the International Accounting Standards Board ('IASB').

Historical cost convention

The financial statements have been prepared under the historical cost convention, except for, where applicable, the revaluation of financial assets and liabilities at fair value through profit or loss, financial assets at fair value through other comprehensive income, investment properties, certain classes of property, plant and equipment and derivative financial instruments.

Going concern

The financial statements have been prepared on a going concern basis. This contemplates continuity of normal business activities and the realisation of assets and settlement of liabilities in the ordinary course of business.

As at 30 June 2022, the Group had a net current asset deficiency, being current assets less current liabilities, of \$3,235,765 (2021: net current assets of \$30,140,031) and net assets of \$17,188,636 (2021: \$35,762,908).

The Directors have considered the performance and position of the Group and consider that the going concern basis is appropriate for the preparation of the financial statements due to the following factors:

- The Group had \$22,673,443 in cash and cash equivalents at period end;
- The Group has no history of inability to pay creditors as they fall due;
- The Group has a supportive working capital cycle whereby customers pay upfront for purchases and suppliers provide credit terms; and
- Operating settings have been adjusted to enable the business to generate a higher level of profitability.

The financial statements do not include any adjustments relating to the recoverability and classification of recorded asset amounts or to the amounts and classification of liabilities that might be incurred should the Group not continue as a going concern.

Notes to the Financial Statements (Continued)

Critical accounting estimates

The preparation of the financial statements requires the use of certain critical accounting estimates. It also requires management to exercise its judgement in the process of applying the Group's accounting policies. The areas involving a higher degree of judgement or complexity, or areas where assumptions and estimates are significant to the financial statements, are disclosed in Note 3.

Parent entity information

In accordance with the *Corporations Act 2001*, these financial statements present the results of the Group only. Supplementary information about the parent entity is disclosed in Note 34.

Principles of consolidation

The consolidated financial statements incorporate the assets and liabilities of all subsidiaries of Cettire Limited ('Parent' or 'Parent Entity') as at 30 June 2022 and the results of all subsidiaries for the year then ended. Cettire Limited and its subsidiaries together are referred to in these financial statements as the 'Group' or 'Cettire'.

Subsidiaries are all those entities over which the Group has control. The Group controls an entity when the Group is exposed to, or has rights to, variable returns from its involvement with the entity and has the ability to affect those returns through its power to direct the activities of the entity. Subsidiaries are fully consolidated from the date on which control is transferred to the Group. They are de-consolidated from the date that control ceases.

Intercompany transactions, balances and unrealised gains on transactions between entities in the Group are eliminated. Unrealised losses are also eliminated unless the transaction provides evidence of the impairment of the asset transferred. Accounting policies of subsidiaries have been changed where necessary to ensure consistency with the policies adopted by the Group.

The acquisition of subsidiaries is accounted for using the acquisition method of accounting. A change in ownership interest, without the loss of control, is accounted for as an equity transaction, where the difference between the consideration transferred and the book value of the share of the non-controlling interest acquired is recognised directly in equity attributable to the parent.

Where the Group loses control over a subsidiary, it derecognises the assets including goodwill, liabilities and non-controlling interest in the subsidiary together with any cumulative translation differences recognised in equity. The Group recognises the fair value of the consideration received and the fair value of any investment retained together with any gain or loss in profit or loss.

Operating segments

Operating segments are presented using the 'management approach', where the information presented is on the same basis as the internal reports provided to the Chief Operating Decision Makers ('CODM'). The CODM is responsible for the allocation of resources to operating segments and assessing their performance.

Refer to Note 4 for further information.

Foreign currency translation

The financial statements are presented in Australian dollars, which is the Group's functional and presentation currency.

Foreign currency transactions

Foreign currency transactions are translated into Australian dollars using the exchange rates prevailing at the dates of the transactions. Foreign exchange gains and losses resulting from the settlement of such transactions and from the translation at financial year-end exchange rates of monetary assets and liabilities denominated in foreign currencies are recognised in profit or loss.

Foreign operations

The assets and liabilities of foreign operations are translated into Australian dollars using the exchange rates at the reporting date. The revenues and expenses of foreign operations are translated into Australian dollars using the average exchange rates, which approximate the rates at the dates of the transactions, for the period. All resulting foreign exchange differences are recognised in other comprehensive income through the foreign currency reserve in equity.

The foreign currency reserve is recognised in profit or loss when the foreign operation or net investment is disposed of.

Revenue recognition

The Group recognises revenue as follows:

Principal versus agent

The Group is primarily responsible for fulfilling the promise (performance obligation) to provide the specified good to the Group's customers. The Group also bears the risk for the acceptance of the good and is responsible for any good in transit. Therefore, the Group is the principal in these transactions and revenue is recognised as the gross selling price net of rebates, discounts and refunds.

Revenue from contracts with customers

Revenue is recognised at an amount that reflects the consideration to which the Group is expected to be entitled in exchange for transferring goods or services to a customer. For each contract with a customer, the Group: identifies the contract with a customer; identifies the performance obligations in the contract; determines the transaction price which takes into account estimates of variable consideration and the time value of money; allocates the transaction price to the separate performance obligations on the basis of the relative stand-alone selling price of each distinct good or service to be delivered; and recognises revenue when or as each performance obligation is satisfied in a manner that depicts the transfer to the customer of the goods or services promised.

Variable consideration within the transaction price, if any, reflects concessions provided to the customer such as discounts, rebates and refunds, any potential bonuses receivable from the customer and any other contingent events. Such estimates are determined using either the 'expected value' or 'most likely amount' method. The measurement of variable consideration is subject to a constraining principle whereby revenue will only be recognised to the extent that it is highly probable that a significant reversal in the amount of cumulative revenue recognised will not occur. The measurement constraint continues until the uncertainty associated with the variable consideration is subsequently resolved. Amounts received that are subject to the constraining principle are recognised as a refund liability.

Sale of goods

Revenue from the sale of goods is recognised at the point in time when the customer obtains control of the goods, which is generally at the time of delivery.

Interest

Interest revenue is recognised as interest accrues using the effective interest method. This is a method of calculating the amortised cost of a financial asset and allocating the interest income over the relevant period using the effective interest rate, which is the rate that exactly discounts estimated future cash receipts through the expected life of the financial asset to the net carrying amount of the financial asset.

Other revenue

Other revenue is recognised when the promised performance obligation is satisfied.

Current and non-current classification

Assets and liabilities are presented in the statement of financial position based on current and non-current classification.

An asset is classified as current when: it is either expected to be realised or intended to be sold or consumed in the Group's normal operating cycle; it is held primarily for the purpose of trading; it is expected to be realised within 12 months after the reporting period; or the asset is cash or cash equivalent unless restricted from being exchanged or used to settle a liability for at least 12 months after the reporting period. All other assets are classified as non-current.

A liability is classified as current when: it is either expected to be settled in the Group's normal operating cycle; it is held primarily for the purpose of trading; it is due to be settled within 12 months after the reporting period; or there is no unconditional right to defer the settlement of the liability for at least 12 months after the reporting period. All other liabilities are classified as non-current.

Deferred tax assets and liabilities are always classified as non-current.

Impairment of non-financial assets

Non-financial assets are reviewed for impairment whenever events or changes in circumstances indicate that the carrying amount may not be recoverable. A review of whether indicators of impairment, which would trigger a review of impairment, is performed at each reporting date. An impairment loss is recognised for the amount by which the asset's carrying amount exceeds its recoverable amount.

Recoverable amount is the higher of an asset's fair value less costs of disposal and value-in-use. The value-in-use is the present value of the estimated future cash flows relating to the asset using a pre-tax discount rate specific to the asset or cash-generating unit to which the asset belongs. Assets that do not have independent cash flows are grouped together to form a cash-generating unit.

Goods and Services Tax ('GST') and other similar taxes

Revenues, expenses and assets are recognised net of the amount of associated GST, unless the GST incurred is not recoverable from the tax authority. In this case it is recognised as part of the cost of the acquisition of the asset or as part of the expense.

Receivables and payables are stated inclusive of the amount of GST receivable or payable. The net amount of GST recoverable from, or payable to, the tax authority is included in other receivables or other payables in the statement of financial position.

Notes to the Financial Statements (Continued)

Cash flows are presented on a gross basis. The GST components of cash flows arising from investing or financing activities which are recoverable from, or payable to the tax authority, are presented as operating cash flows.

Commitments and contingencies are disclosed net of the amount of GST recoverable from, or payable to, the tax authority.

Government grants

Government grants are recognised in profit or loss on a systematic basis over the periods in which the entity recognises as expenses the related costs for which the grants are intended to compensate.

Note 3. Critical accounting judgements, estimates and assumptions

The preparation of the financial statements requires management to make judgements, estimates and assumptions that affect the reported amounts in the financial statements. Management continually evaluates its judgements and estimates in relation to assets, liabilities, contingent liabilities, revenue and expenses. Management bases its judgements, estimates and assumptions on historical experience and on other various factors, including expectations of future events, management believes to be reasonable under the circumstances. The resulting accounting judgements and estimates will seldom equal the related actual results.

Judgements, other than those disclosed in the accounting policies above or which are subject to estimation and discussed separately below, which are critical to these financial statements include:

Recovery of deferred tax assets

The Group has recognised deferred tax assets of \$11,927,754 (2021: \$2,466,813) on the statement of financial position. Deferred tax assets are recognised for deductible temporary differences and tax losses only if the Group considers it is probable that future taxable amounts will be available to utilise those temporary differences and losses. Based on the Group's historical performance and forecasts of future performance, the Group has determined that it is probable that these deferred tax assets will be utilised. If that judgement changed, the deferred tax assets would not be recognised on the statement of financial position and instead be disclosed separately in the notes to the financial statements.

Impairment of non-financial assets

The Group has considered whether there are any indicators of impairment which may apply to non-financial assets, particularly intangible assets, identifying matters which may indicate an impairment under AASB 136 Impairment of Assets. Following this assessment, the Group has performed an impairment assessment to consider whether any impairment arises, concluding that there

is no impairment in the year (2021: none). Any impairment which arose would result in a reduction to the carrying value of intangible assets on the statement of financial position and a loss in the statement of profit or loss and other comprehensive income.

Estimates which have the most significant risk of material adjustment in the following 12 months include:

Share-based payment transactions

The Group measures the cost of equity-settled transactions with employees by reference to the fair value of the equity instruments at the date at which they are granted. In respect of options, the fair value is determined by using either the Binomial, Black-Scholes or Monte Carlo model taking into account the terms and conditions upon which the instruments were granted.

Estimation of useful lives of intangible assets

The Group determines the estimated useful lives and related amortisation charges for its finite life intangible assets, as set out in note 11. The Group has reviewed the useful lives of intangible assets in the year, including by comparison to comparable companies, and concluded that the useful lives adopted remains appropriate. The useful lives could change significantly as a result of technical innovations or some other event. The amortisation charge will increase where the useful lives are less than previously estimated lives, or technically obsolete or non-strategic assets that have been abandoned or sold will be written off or written down.

Contract liabilities and Stock-in-transit

In determining the level of the contract liabilities (refer to Note 13) and stock-in-transit (refer to Note 9), the Group has made judgements in respect of the expected time to complete its performance obligations for delivery of goods to the customer. Historical experience has been taken into account in determining the contract liabilities and stock-in-transit.

R&D tax incentive accrual

The Group's research and development activities are eligible under an Australian government tax incentive for eligible expenditure. The Group has assessed these activities and expenditure to determine which are likely to be eligible under the incentive scheme. Amounts are recognised when it has been established that the conditions of the tax incentive have been met and that the expected amount can be reliably measured.

Judgement is applied to each transaction that the Group incurs each financial year, by determining a percentage of the transaction that relates to R&D. R&D income is determined using eligibility criteria and percentages of eligibility estimated by management. These estimated eligibility percentages determine the base for which the R&D tax incentive accrual is calculated.

Note 4. Operating segments

Identification of reportable operating segments

The Group is organised into one (1) operating segment: online retail sales. The determination of this operating segment is based on the internal reports that are reviewed and used by the CEO (who is identified as the Chief Operating Decision Maker ("CODM")) in assessing performance and in determining the allocation of resources.

The CODM reviews EBITDA (earnings before interest, tax, depreciation and amortisation). The accounting policies adopted for internal reporting to the CODM are consistent with those adopted in the financial statements.

The information reported to the CODM is on a monthly basis.

Major customers

During the reporting period and the comparative period, no individual customer contributed more than 10 per cent of the Group's revenue (2021: none).

Disaggregation of revenue and non-current assets by Geographical regions

The Group operates in Australia and internationally. Revenue is attributed to the country where the customer payment is registered i.e. billing address.

Note 20. Financial instruments

Financial risk management objectives

The Group's activities expose it to a variety of financial risks: market risk (including foreign currency risk, price risk and interest rate risk), credit risk and liquidity risk. The Group's overall risk management program focuses on the unpredictability of financial markets and seeks to minimise potential adverse effects on the financial performance of the Group. The Group uses derivative financial instruments such as forward foreign exchange contracts to mitigate certain risk exposures. Derivatives are exclusively used for hedging purposes, i.e. not as trading or other speculative instruments. The Group uses different methods to measure different types of risk to which it is exposed. These methods include sensitivity analysis in the case of interest rate, foreign exchange and other price risks, ageing analysis for credit risk and beta analysis in respect of investment portfolios to determine market risk.

Risk management is carried out by senior finance executives ('finance') under policies approved by the Directors ('the Board'). These policies include identification and analysis of the risk exposure of the Group and appropriate procedures, controls and risk limits. Finance identifies, evaluates and mitigates financial risks within the Group's operating units. Finance reports to the Board on a monthly basis.

Market risk

Foreign currency risk

The Group undertakes certain transactions denominated in foreign currency and is exposed to foreign currency risk through foreign exchange rate fluctuations.

Foreign exchange risk arises from future commercial transactions and recognised financial assets and financial liabilities denominated in a currency that is not the entity's functional currency. The risk is measured using sensitivity analysis and cash flow forecasting.

Revenue from the sale of goods is recognised at the point in time when the customer obtains control of the goods, which is generally at the time of delivery, and the performance obligation is satisfied in accordance with AASB 15 <i>Revenue from Contracts with Customers</i>. The majority of the Group's sales transactions are completed through the "drop-ship" model, whereby suppliers deliver goods directly to the Group's customers. The Group is the principal in these transactions. Therefore, revenue is recognised as the gross selling price net of returns and discounts. Revenue is only recognised when delivery is made to the customer, requiring an assessment at the end of the reporting period for all orders shipped but not yet delivered. Auditing standard ASA 240 <i>The Auditor's Responsibilities Relating to Fraud in an Audit of a Financial Report</i> states that there is a presumed fraud risk that revenue may be misstated due to improper revenue recognition. This area is a key audit matter due to the judgement involved in this assessment and the daily volume of online retail transactions. Intangible assets (Note 11)	
The Group holds intangible assets, including capitalised development costs, of \$12.07m. These intangible assets are being amortised over a five-year period. An amortisation expense of \$1.9m has been included in the statement of profit or loss and other comprehensive income. AASB 138 <i>Intangible Assets</i> sets out the specific requirements to be met to capitalise development costs. Intangible assets should be amortised over their useful economic lives in accordance with AASB 138. As these assets are considered to be in use, management is required to assess at each reporting date if there are any indicators of impairment that may suggest the carrying value is in excess of the recoverable value. There is significant judgment in assessing the useful economic lives of internally generated intangible assets, whether development costs meet the recognition criteria set out in AASB 138, whether there are any impairment indicators and if any impairment arises. This is a key audit matter due to the significant judgement involved in the impairment indicator analysis and any associated impairment assessment, the subjectivity and judgement applied in the assessment of whether costs meet the development phase criteria described in AASB 138, the estimate of the assets' useful lives, and the financial significance of the assets in the statement of financial position. Research and development tax incentive (Note 15)	
The Group obtains research and development tax offsets from the Australian Commonwealth Government that reduces the overall net cost incurred by the Group in respect of its research and development activities. The incentive is recognised in profit or loss over the periods necessary to match the benefit of the credit with the costs it intends to compensate. Where the research and development is, in whole or in part, capitalised, the Group has accounted for the tax benefit as deferred income that is recognised in profit or loss on a systematic basis matching the useful life of the asset. The Group has recognised research and development income of \$0.8m for the 2022 financial year. This area is a risk due to the judgements and estimates in determining which research and development spend is eligible for a refundable tax offset. This area is a key audit matter due to the judgement involved by the Group in assessing the appropriate quantum of the research and development tax incentive to recognise due to the complexity of the rules and regulations governing the tax incentive.	Our procedures included, amongst others: • Obtaining management's research and development claims and reviewing if the claim was in line with legislation; • Agreeing management's claim to the income tax return; • Utilising an auditor expert to assess the appropriateness of the claim; • Recalculating deferred income and income released in line with the amortisation of the associated assets; and • Assessing whether the disclosures in the financial statements, including critical judgements and estimates, are appropriate.
