4. Present relevant interests

During the period 17 August 2009 to 19 August 2009, 544,289 shares in MMC Contrarian Limited were acquired by GPG Australia Nominees Limited. These shares were incorrectly recorded in Section 4 of the Forms 604 submitted since 20 August 2009 as being held by Guinness Peat Group (Australia) Pty Limited. As a consequence, the holding in MMC Contrarian Limited by GPG Australia Nominees Limited was understated by 544,289 shares and the holding by Guinness Peat Group (Australia) Pty Limited was overstated by 544,289 shares. The total number of shares in MMC Contrarian Limited held by Guinness Peat Group plc and its subsidiaries was correctly stated. Section 4 of this Form 604 now correctly records the respective holdings.
