Lapse and Issue of Unquoted Options

Emerging Northern Territory lithium developer Core Lithium Ltd (ASX: CXO) (**Core or Company**), advises that 58,104,000 unlisted options (exercise price of \$0.08) lapsed on 21 June 2019 in accordance with the terms of those securities.

Additionally, further to the announcement of 5 June 2019, Core has issued 4,000,000 unquoted options to the underwriters of the Company's Share Purchase Plan at a price of \$0.00001, exercise price of \$0.06 and expiry of 30 June 2022. The issue of underwriter options has been made under the Company's existing 15% placement capacity.
