Shares issued under Share Issue Notice under section 708A(5)(e) of the Corporations Act 2001

This notice is given by Core Lithium Ltd (ABN 80 146 287 809) (the **Company**) under section 708A(5)(e) of the Corporations Act 2001 (**Corporations Act**).

The Company has issued the following ordinary shares (**Shares**), together, the **Share Issue**.

- 6,287,665 Shares at an issue price of A\$0.45 per Share to investors that have exercised unquoted options;
- 5,000,000 Shares at an issue price of A\$0.06 per Share to director Stephen Biggins upon exercise of unquoted options; and
- 4,198,332 Shares for nil consideration to director Stephen Biggins upon exercise of vested performance rights.

- (b) this notice is being given under section 708A(5)(e) of the Act;
- (c) as a disclosing entity, the Company is subject to regular reporting and disclosure obligations;

 - (ii) section 674 of the Act; and
- (e) as at the date of this notice, there is no information that is “excluded information” within the meanings of sections 708A(7) and 708A(8) of the Act.
