Coventry Group Limited (**Coventry**) (ASX: CYG) is pleased to announce the successful completion of the 1 for 5 accelerated non-renounceable pro-rata entitlement offer announced on 26 September 2018, with approximately 3.7 million new fully paid ordinary shares (**Shares**) allotted today in respect of the retail component of the entitlement offer (**Retail Entitlement Offer**).
