FOUR EAGLES JOINT VENTURE TO SUPPORT DINGEE AND PYRAMID HILL COMMUNITIES

- The Four Eagles Joint Venture will contribute \$100,000 to the Dingee Bush Nursing Centre and \$8,000 to the Pyramid Hill and District Community Emergency Response Team and Ambulance Victoria
 - Contributions recognise the valuable work that these organisations carry out in the communities in which we undertake exploration

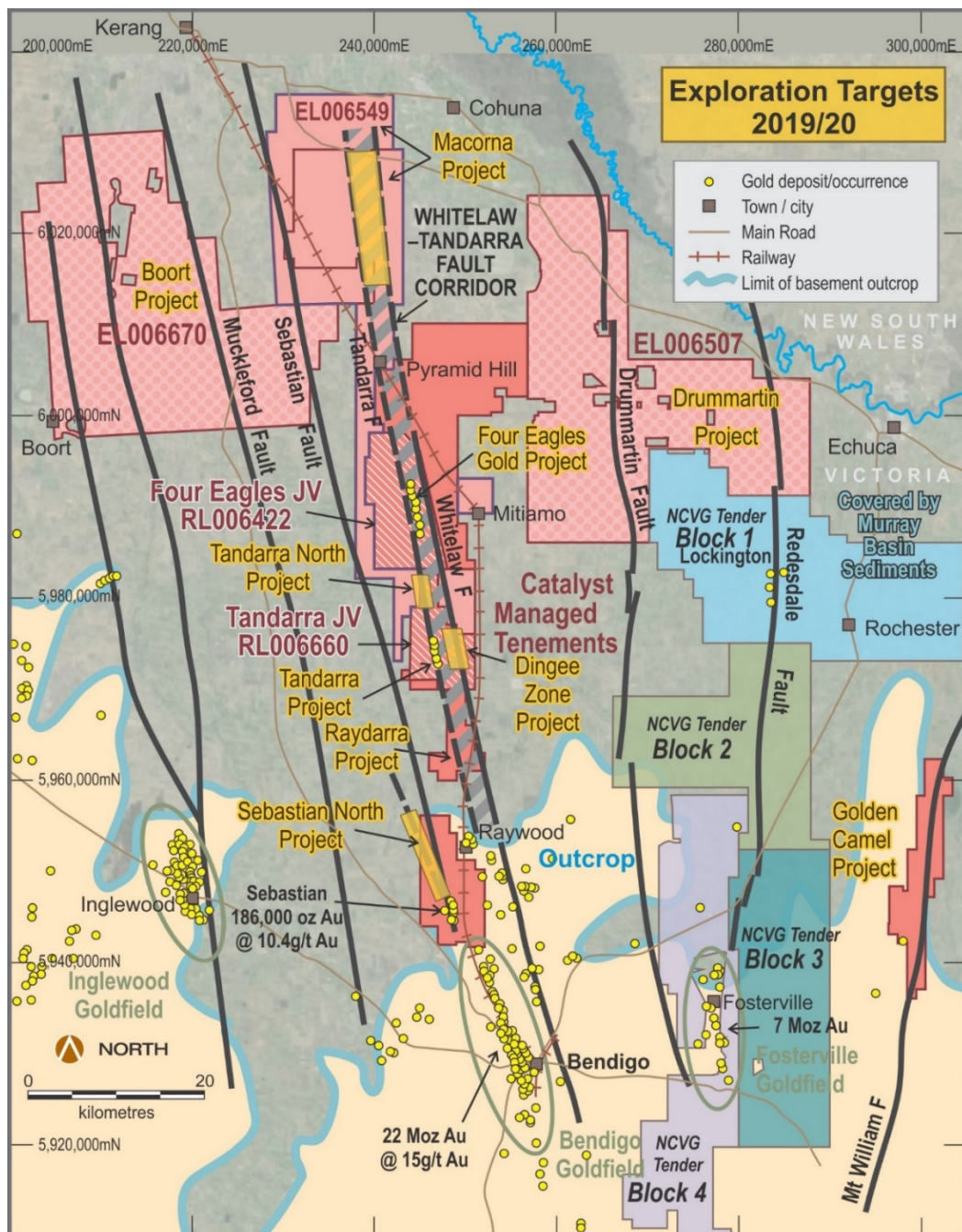


Figure 1: Whitelaw Gold Belt Tenement Holdings showing major Catalyst managed projects and location of Four Eagles Gold Project

Catalyst Metals Limited (**Catalyst** or the **Company**) (ASX: CYL) is pleased to announce that on behalf of the Four Eagles Joint Venture with **Gold Exploration Victoria Pty Ltd** (a subsidiary of **Hancock Prospecting Pty Ltd**), that the Joint Venture will make a contribution to three health related facilities in Dingee and Pyramid Hill in Victoria. These organisations provide valuable assistance to the health and wellbeing of the broader communities in which the Four Eagles Joint Venture carries out its exploration activities in the vicinity of Dingee, Mitiamo, Pyramid Hill and Boort (Figure 1).

The Dingee Bush Nursing Centre will receive \$100,000 for vehicle upgrades which will broaden the scope of nursing services throughout the district by increasing patient and equipment carrying capacity.

The Centre is a non-bed primary health service that provides Dingee and surrounding community with access to essential health and registered nursing services, including Remote Assistance Nurses who are co-responders with Ambulance Victoria to emergency and medical incidents. The Centre also hosts a range of visiting professional and ancillary health service providers for the region.

Ambulance Victoria's Pyramid Hill and District Community Emergency Response Team will receive \$8,000 which will enable a much-needed upgrade of training equipment and the installation of a publicly accessible defibrillator in Pyramid Hill.

The Response Team is comprised of trained community-based volunteer first responders who provide advanced first aid and support to patients while awaiting the arrival of assisting paramedics.

Exploration activities for the Four Eagles Joint Venture are coordinated from the Catalyst office in Bendigo, with annual expenditure across the region of more than \$10 million. Local and regional suppliers are used wherever practicable.

As well as forging relationships with landholders upon whose lands they explore, the Joint Venture partners and personnel are continually seeking to integrate with their host communities.

Catalyst's Technical Director Bruce Kay said "Even though we are still at the exploration stage, both Catalyst and Hancock Prospecting recognise the importance of building strong relationships with the communities where we explore. These donations recognise the valuable community services that the Dingee Bush Nursing Centre, the Pyramid Hill Community Emergency Response Team and Ambulance Victoria provide, and will further enhance the health and welfare of these communities."
